In producing herewith arrested accd. 1) Biswajit Dubey (38) S/o Arjun Dubey, 2) Biswanath Dubey (34) S/o Arjun Dubey both of Vill- Loyara, 3) Subir Bauri (26) S/o Lt. Manindranath Bauri of Vill- Para Patibaid, 4) Iswar Roy (28) S/o Ranjit Roy of Vill- Baishyakuli all of PS- Para, Dist-Purulia and seized articles i.e. (i) One PS Vehicle having bearing Regd. No- WB24K/7871 with damaged condition (Back side glass broken), (ii) Some Pcs of broken glass of the back portion of said vehicle, (iii) some brickbats and (iv) Three bamboo sticks under proper seizure list, I SI Biswajit Banerjee, (S/O Swapan Kr Banerjee, DOB 27.3.1983), O/C Para PS do hereby lodge this FIR as suo motto against arrested accd persons 1) Biswajit Dubey (38) S/o Arjun Dubey, 2) Biswanath Dubey (34) S/o Arjun Dubey both of Vill- Loyara, 3) Subir Bauri (26) S/o Lt. Manindranath Bauri of Vill-Para Patibaid, 4) Iswar Roy (28) S/o Ranjit Roy of Vill- Baishyakuli all of PS- Para, Dist- Purulia and 1) Alok Mukherjee, 2) Sudip Mukherjee @ Beauty both of Jhapra, 3) Nibas Dubey of Loyara all of Ps- Para, Dist- Purulia and 60/70 others unknown to the effect that today at around 19.25 hrs. I received a telephonic information from Loyara village, PS- Para that about 65/70 persons have assembled near Jhapra Petrol Pump and assaulting one person suspecting him to be a thief. The suspected person was coming from Anara side with one cow and a bull and the local persons detained him suspecting that he had stolen the cow and bull and an agitation is going on there. Accordingly I diarized the fact in G.D. vide Para PS GDE No- 782 Dtd- 19.07.2020. and I briefed available Officers and force about the matter and myself along with SI Parimal Ghosh, ASI Santosh Roy, C/976 Shiba Prasad Mukherjee, C/28 Shyamapada Gorai, C/1034 Fakir Ch. Mahato and CV-Hrishikesh Mudi all of Para PS left for working out that information (vide GDE No- 783 Dtd-19.07.2020) by two vehicles.

We reached at the spot at around 19.50 hrs. I found a Mob of 65/70 persons assembled there encircling one youth and they were assaulting him. They demanded that he had stolen one cow and a bull. Biswanath Dubey, Subir Bauri, Sudip Mukherjee, Alok Mukherjee are well known to me. They were leading the mob. I asked them to give a written complaint. I was trying to pacify the mob. None of them was wearing Mask and did not care to maintain social distance though we tried to make them aware about the spreading of COVID-19 pandemic.

At around 20.15 hrs. Biswanath Dubey submitted before me a written complaint against the suspected person namely Alamgir Mallik of Hariharpur with the allegation of theft of those animals. Accordingly I forwarded the complaint through ASI Santosh Roy to PS to start a case U/S- 379/411 IPC.

When I was going to take the detained accused person under my custody the mob prevented us. I asked the persons, who were leading the mob, to hand over said Alamgir Mallik to us. Hearing this 1) Biswajit Dubey (38) S/o Arjun Dubey, 2) Biswanath Dubey (34) S/o Arjun Dubey both of Vill- Loyara, 3) Subir Bauri (26) S/o Lt. Manindranath Bauri of Vill- Para Patibaid, 4) Iswar Roy (28) S/o Ranjit Roy of Vill- Baishyakuli all of PS- Para, Dist- Purulia, 5) Alok Mukherjee, 6) Sudip Mukherjee @ Beauty both of Jhapra, 7) Nibas Dubey of Loyara all of Ps- Para, Dist- Purulia became violent and started arguing with me with bad language with intend to instigate the mob against us. Immediately the mob became violent and started beating said Alamgir. We tried to rescue him but the unruly mob started assaulting us with lathi, iron rod etc. I asked them to disperse but they did not care. I declared the mob as unlawful assembly but they became more desperate. We somehow rescued Alamgir and put him in our vehicle WB24K/7871. They tried to snatch away Alamgir Mallik

from our custody demanding that they would mete out stern punishment with their own hand and started pelting stone aiming at the vehicle. As a result the vehicle got damaged. Finding no other alternative we applied force and arrested 1) Biswajit Dubey (38) S/o Arjun Dubey, 2) Biswanath Dubey (34) S/o Arjun Dubey both of Vill- Loyara, 3) Subir Bauri (26) S/o Lt. Manindranath Bauri of Vill- Para Patibaid, 4) Iswar Roy (28) S/o Ranjit Roy of Vill- Baishyakuli all of PS- Para, Dist-Purulia from the spot and all other managed to escape from the spot. Due to their vandalism and attack our men C/976 Shiba Prasad Mukherjee and CV- Hrishikesh Mudi got serious injury and Alamgir also received injury. I brought all of them to Para BPHC where said C/976 Shiba Prasad Mukherjee is admitted. I seized (i) One PS Vehicle having bearing Regd. No- WB24K/7871 with damaged condition (Back side glass broken), (ii) Some Pcs of broken glass of the back portion of said vehicle, (iii) some brickbats and (iv) Three bamboo sticks from the P.O. under proper seizure list.

Hence I do hereby lodge this case as suo moto vide Para PS Case No- 88/2020 Dtd-19.07.2020, U/S-147/148/149/151/152/153/186/188/325/332/333 IPC, 3 & 4 P.D.P.P. Act., 9 M.P.O. Act and 51(1)(b) of National Disaster Management Act. 2005 against above noted accd. persons and directed SI Sukumar Hota of Anara OP to investigate the case.
