Sub: Request for lodging F.I.R. against arrested accused persons 1) Ajoy Rajowar (22 Yrs) S/o Shibaram Rajowar, 2) Shibaram Rajowar (60 Yrs) S/o Lt. Khudiram Rajowar both of Vill- Bhatdih and 3) Samsuddin Ansary (33 Yrs) S/o Haru Ansary of Vill- Bathanbari all of PS- Para, Dist- Purulia.

Sir,

In producing herewith 03(Three) arrested accused persons namely persons 1) Ajoy Rajowar (22 Yrs) S/o Shibaram Rajowar, 2) Shibaram Rajowar (60 Yrs) S/o Lt. Khudiram Rajowar both of Vill- Bhatdih and 3) Samsuddin Ansary (33 Yrs) S/o Haru Ansary of Vill- Bathanbari all of PS- Para, Dist- Purulia.

I beg to state that today (29.07.2020), I was directed to find out whether the lock down has been implanted properly by Nadiha More area or not. Accordingly, I had been to Nadiha More at about 17.05 hrs and found that a gathering appeared at Nadiha More, none of them was wearing mask. On seeing Police party they have tried to escape from the grip of police party but some failed to escape due to efficiency effort of police party. On being asked they disclosed their identity as noted above.

They violated the order duly promulgated by government through public servants and through media etc for prevention of attack from CORONA Virus/COVID-19. They are creating annoyance to the society & violated govt. order. Though lockdown is going on throughout the District of Purulia in view of Pandemic of COVID-19 outbreak vide Govt. of India consolidated order No- 40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020, 10/04/2020 & 01/05/2020. And orders of Govt. of West Bengal vide Order No- 177-CS/2020 dt-18.05.2020 & 218-CS/2020 dt-30.05.2020 and order No- 272-CS/2020 Dtd. 30.06.2020 and memo no. 283-CS/2020 Dtd. 21.07.2020 for complete restriction measure.

I arrested them for Disobedience to order duly promulgated by public servant after maintaining all rules of arrest, Issued memo of arrest & Inspection Memo. I informed them & their relatives regarding the ground of arrest i.e.as per section 3 of the Epidemic Diseases Act, 1897, provide penalties for disobeying any regulation or order made under the Act. These are according to Section 188 of the Indian Penal Code (Disobedience to order duly promulgated by public servant). At prima facie there were sufficient evidences to secure their detention. All the process was done in between 17.25 hrs to 17.35 hrs. There was every chance of breach of peace and requiring of offence if not arrested.

Therefore, I pray a specific case may kindly be lodge against 1) Ajoy Rajowar (22 Yrs) S/o Shibaram Rajowar, 2) Shibaram Rajowar (60 Yrs) S/o Lt. Khudiram Rajowar both of Vill- Bhatdih and 3) Samsuddin Ansary (33 Yrs) S/o Haru Ansary of Vill- Bathanbari all of PS- Para, Dist- Purulia as they disobeyed Govt. order and committed negligent Act likely to spread infection of diseases dangerous to lie and violated Quarantine rule U/S 188/34 IPC and Section 51(1)(b) National Disaster Management Act- 2005 and arrange for investigation.
