Sir,

In producing here with 02(Two) arrested accused persons namely (1) Prasanta Kr. Singha (32yrs), S/O- Gurupada Singha of vill-Laharia, PS-Puncha, Dist- Purulia (2) Aditya Panda (35 yrs), S/O- Nisakar Panda of vill- Shyampur, PS-Puncha, Dist- Purulia along with Memo of arrest & other relevant papers.

I beg to state that today (23/07/2020) I was engaged in day mobile duty near Bagda market with forces to find out whether the complet lock down has been implanted properly at PS jurisdiction area or not. This refers to Puncha PS GDE No- 918 Dtd- 23/07/2020 and CC No-2078 Date-23/07/2020 Accordingly, I was performing duty near Bagda market at about 11.25 hrs, the above noted people were roaming aimlessly without wearing mask. I detained them and on being asked the accd people could not give any satisfactory answer regarding their movement on public place without using mask. As they refused to comply the direction given by Govt to combat covid-19 pandemic and they committed negligent act likely to spread infection of diseases dangerous to life and violated Government rules which was promulgated by Govt through public servants and through media etc for prevention of attack hence I arrested them for disobeying Govt order vide order No-382-I.S.S./2M-24/2020, Dated-2nd July 2020 and memo no- 283-CS/2020, dtd. 21.07.2020 of compulsory wearing of mask during this pandemic situation and not following norms of complet lockdown. I issued arrest memo and informed them the ground of arrest as per section 3 of the Epidemic Diseases Act, 1897, duly signed by the accd people. The whole process was done in between 11.25 hrs to 11.35 hrs.

Therefore, I pray that a specific case may kindly be started against (1) Prasanta Kr. Singha (32yrs), S/O- Gurupada Singha of vill-Laharia, PS-Puncha, Dist- Purulia (2) Aditya Panda (35 yrs), S/O- Nisakar Panda of vill- Shyampur, PS-Puncha, Dist- Purulia, as they disobeyed Govt order and committed negligent act likely to spread infection of diseases dangerous to life, U/S 188/34 IPC and Sec 51 of National Disaster Management Act, 2005 and arrange for its investigation.
