Sir.

In producing here with 03(Three) arrested accused persons namely (1) Laltu Mudi (20yrs), S/O- Jiten Mudi (2) Barun Ch. Mudi (30 yrs) S/O Lt. Haradhan Mudi (3) Durjadhan Mudi (27yrs) S/O Santosh Mudi all of vill-Algumir, PS-Puncha, Dist-Purulia along with Memo of arrest & other relevant papers.

I beg to state that today (23/07/2020) I was engaged in day mobile duty near Laharia more with forces to find out whether the complete lock down has been implanted properly at PS jurisdiction area or not. This refers to Puncha PS GDE No- 924 Dtd- 23/07/2020 and CC No-2078 Date-23/07/2020 Accordingly, I was performing duty near Laharia more at about 13.25 hrs, the above noted people were roaming aimlessly without wearing mask. I detained them and on being asked the accd people could not give any satisfactory answer regarding their movement on public place without using mask. As they refused to comply the direction given by Govt to combat covid-19 pandemic and they committed negligent act likely to spread infection of diseases dangerous to life and violated Government rules which was promulgated by Govt through public servants and through media etc for prevention of attack hence I arrested them for disobeying Govt order vide order No-382-I.S.S./2M-24/2020, Dated-2nd July 2020 and memo no- 283-CS/2020, dtd. 21.07.2020 of compulsory wearing of mask during this pandemic situation and not following norms of complete lockdowan I issued arrest memo and informed them the ground of arrest as per section 3 of the Epidemic Diseases Act, 1897, duly signed by the accd people. The whole process was done in between 13.25 hrs to 13.55 hrs.

Therefore, I pray that a specific case may kindly be started against (1) Laltu Mudi (20yrs), S/O- Jiten Mudi (2) Barun Ch. Mudi (30 yrs) S/O Lt. Haradhan Mudi (3) Durjadhan Mudi (27yrs) S/O Santosh Mudi all of vill-Algumir, PS-Puncha, Dist-Purulia, as they disobeyed Govt order and committed negligent act likely to spread infection of diseases dangerous to life, U/S 188/34 IPC and Sec 51of National Disaster Management Act, 2005 and arrange for its investigation.
