In producing here with 05(Five) arrested accused persons namely (1) Arjun Bauri (35yrs), S/O- Lt. Bablu Bauri (2) SK Badsha(24 yrs), S/O- SK Kawasar (3) Juman Khalifa(30 yrs), S/O- Surman Khalifa (4) Surja Bauri(35 yrs), S/O- Panchu Bauri all of vill- Mahespur, PS- Sonamukhi, Dist. Bankura (5) Subodh Layek (40 yrs), S/O- Sankar Chandra Layek of vill- Poradih, PS- Puncha, Dist. Purulia of PS-Puncha, Dist-Purulia along with Memo of arrest & other relevant papers.

I beg to state that today (19/07/2020) at 09.05 hrs, I was engaged in day mobile duty near Tusugoria more with other officers and forces to find out whether the lock down has been implanted properly at PS jurisdiction area or not. This refers to Puncha PS GDE No- 758 Dtd- 19/07/2020 and CC No-2036 Date-19/07/2020 Accordingly, I was performing duty at near Tusugoria more at about 12.05 hrs, the above noted people were roaming aimlessly without wearing mask. I detained them and on being asked the accd people could not give any satisfactory answer regarding their movement on public place without using mask. As they refused to comply the direction given by Govt to combat covid-19 pandemic and they committed negligent act likely to spread infection of diseases dangerous to life and violated Government rules which was promulgated by Govt through public servants and through media etc for prevention of attack hence I arrested them for disobeying Govt order vide order No-382-I.S.S./2M-24/2020, Dated-2nd July 2020 of compulsory wearing of mask during this pandemic situation. I issued arrest memo and informed them the ground of arrest as per section 3 of the Epidemic Diseases Act, 1897, duly signed by the accd people. The whole process was done in between 10.55 hrs to 11.35 hrs.

Therefore, I pray that a specific case may kindly be started against (1) Arjun Bauri (35yrs), S/O- Lt. Bablu Bauri (2) SK Badsha(24 yrs), S/O- SK Kawasar (3) Juman Khalifa(30 yrs), S/O- Surman Khalifa (4) Surja Bauri(35 yrs), S/O- Panchu Bauri all of vill- Mahespur, PS- Sonamukhi, Dist. Bankura (5) Subodh Layek(40 yrs), S/O- Sankar Chandra Layek of vill- Poradih, PS- Puncha, Dist. Purulia as they disobeyed Govt order and committed negligent act likely to spread infection of diseases dangerous to life, U/S 188/34 IPC and Sec 51of National Disaster Management Act, 2005 and arrange for its investigation.
