Sir,

In producing here with 02(Two) arrested accused people namely (1) Alok Karmakar(64yrs), S/O- Lt. Fakir Karmakar (2)Biswajit Mandal(45yrs) S/O Niranjana Mandal both of vill-Ramakundhu, Kundhurka PS-Puncha, Dist- Purulia along with Memo of arrest & other relevant papers.

I beg to state that today (24/07/2020) I was engaged in day mobile duty Ramakundhi near Kundhurka more with forces to find out whether the lock down has been implanted properly at PS jurisdiction area or not. This refers to Puncha PS GDE No- 964 Dtd- 24/07/2020 and CC No-2088 Date-24/07/2020 Accordingly, I was performing duty at Ramakundhu near Kundhurka more at about 12.05 hrs, the above noted people were roaming aimlessly without wearing mask. I detained them and on being asked the accd people could not give any satisfactory answer regarding their movement on public place without using mask. As they refused to comply the direction given by Govt to combat covid-19 pandemic and they committed negligent act likely to spread infection of diseases dangerous to life and violated Government rules which was promulgated by Govt through public servants and through media etc for prevention of attack hence I arrested them for disobeying Govt order vide order No-382-I.S.S./2M-24/2020, Dated-2nd July 2020 of compulsory wearing of mask during this pandemic situation. I issued arrest memo and informed them the ground of arrest as per section 3 of the Epidemic Diseases Act, 1897, duly signed by the accd people. The whole process was done in between 12.05 hrs to 12.25 hrs.

Therefore, I pray that a specific case may kindly be started against (1) Alok Karmakar(64yrs), S/O- Lt. Fakir Karmakar (2)Biswajit Mandal(45yrs) S/O Niranjana Mandal both of vill-Ramakundhu, Kundhurka PS-Puncha, Dist- Purulia, as they disobeyed Govt order and committed negligent act likely to spread infection of diseases dangerous to life, U/S 188/34 IPC and Sec 51 of National Disaster Management Act, 2005 and arrange for its investigation.
