In sending here with the original FIR copy, arrest memo, PR & Bail bond of arrested accd. persons namely (1) Mangal Ch. Mahato(45yrs), S/O- Bhaku Mahato (2) Srikanta Rakshit (32yrs), S/O- Mahadeb Rakshit both of vill-Puncha, PS-Puncha Dist- Purulia of this case.

in this case and beg to report that On 29/07/2020 O/C Puncha PS received a typed complaint from SI Sunil Kr. Banerjee of Puncha PS Dist - Purulia to the effect that on 26/07/2020 he was engaged in day mobile duty at near Puncha Market with forces to find out whether the lock down has been implanted properly at PS jurisdiction area or not. This refers to Puncha PS GDE No- 1164 Dtd- 29/07/2020 and CC No-2136 Date-29/07/2020 Accordingly, I was performing duty at near Puncha Market at about 16.55 hrs, the above noted people were roaming aimlessly without wearing mask. he detained them and on being asked the accd people could not give any satisfactory answer regarding their movement on public place without using mask. As they refused to comply the direction given by Govt to combat covid-19 pandemic and they committed negligent act likely to spread infection of diseases dangerous to life and violated Government rules which was promulgated by Govt through public servants and through media etc for prevention of attack hence he arrested them for disobeying Govt order vide order No-382-I.S.S./2M-24/2020, Dated-2nd July 2020 of compulsory wearing of mask during this pandemic situation. he issued arrest memo and informed them the ground of arrest as per section 3 of the Epidemic Diseases Act, 1897, duly signed by the accd people. The whole process was done in between 17.05 hrs to 17.15 hrs. Over this started Puncha PS Case No 56/20 dated- 29/07/2020 U/S- 188/34 IPC and Sec 51of National Disaster Management Act, 2005 and endorsed to me for investigation.

There after namely Bhajahari Dutta, S/O- Fatik Dutta, of vill- Puncha, Dist. Purulia came to PS and turned up surety for arrested accd persons namely (1) Mangal Ch. Mahato(45yrs), S/O- Bhaku Mahato (2) Srikanta Rakshit (32yrs), S/O- Mahadeb Rakshit both of vill-Puncha, PS-Puncha Dist- Purulia PS they were released on bail after furnishing proper bail bond and PR bond duly sign by them.
