Respected Sir,

In producing herewith the driver namely 1) Mithun Mahato (29 yrs) S/O Banshidhar Mahato & 2) Chiranjit Mahato (19 yrs) s/o Manik Mahato both of Vill- Gunja, PS- Joypur, Dist- Purulia along with both seized vehicles (Tractor) bearing Reg. No 1) WB55-3843 & 2) WB37B-1582 and attached with Seizure list, Memo of Arrest and Inspection Memo in respect of the supra persons before you.

The nub of the fact in a nutshell is that on 04.07.2020 at 17:05 hrs I ASI Srimanta Sing Sardar along with force 1) C/1175 Srikanta Mukherjee, 2) C/857 Chapulal Murmu & 3) JC/1420 Prasenjit Mahato all of Purulia (M) PS left the PS for performing evening mobile duty vide Purulia (M) PS CC No 1868/2020 and GDE No 179 Dt. 04.07.2020 in PS area. During my evening mobile duty, I received a tip off at 17:35 hrs that 02 (two) suspicious tractor loaded with sand were coming from Kantabera village toward Chas More. Subsequently, I along with force proceeded towards Kantabera village to work out the tip off. While I along with force arrived near Garafushra village more and found that 02 (two) tractors were proceeding towards Chas More along Chirka Road. I along with force intercepted 02 vehicles (Tractor) bearing Reg. No 1) Reg. No WB55-3843 & 2) WB37B-1582 attached with Trolley is each tractor loaded with sand at 20:05 hrs and I found that the vehicles as well as goods as identical as I received prior information. On being asked, the driver of the both vehicles disclosed their name noted in the supra. I asked both the driver of the vehicles to produce the valid documents in respect of the vehicles as well as the loaded sand. But both the drivers of the said vehicles could not able to produce any kind of documents in respect of those Tractors and the sand. I repeatedly asked both the drivers to produce the valid paper but they stated differently in different times. The incoherent statement of both the drivers purported to be a suspicious to us. It was ascertained that the drivers of the those tractors loaded the said sand in cahoots with the owner of those vehicles by illegal means for selling the same to make profit by dishonestly and they had been running a clandestine business. So it is reasoned to belief that they in cahoots with the owner of those vehicles procured the said sand form Kansai River near Kantabera village side by fraudulently means or theft by any means for transporting the same to run clandestine business. So I, seized both the tractors bearing Reg. No 1) Reg. No WB55-3843 & 2) WB37B-1582 attached with Trolley in each loaded with sand under proper seizure list in presence of available witnesses duly signed by them and also arrested both the drivers namely 1) Mithun Mahato (29 yrs) S/O Banshidhar Mahato, 2) Chiranjit Mahato (19 yrs) s/o Manik Mahato both of Vill- Gunja, PS- Joypur, Dist- Purulia after informing the ground of their arrest and issued Memo of Arrest against them. Thereafter, I brought those seized tractors to Purulia (M) PS compound.

Under the above facts and circumstances kindly take lawful action against both the drivers namely 1) Mithun Mahato (29 yrs) S/O Banshidhar Mahato, 2) Chiranjit Mahato (19 yrs) s/o Manik Mahato both of Vill- Gunja, PS- Joypur, Dist- Purulia and the owners of the both vehicles as they committed offence u/s 379/411/414/120B of the IPC & 21(I) (4) of Mines and Minerals (D&R) Act-1957.
