Respected Sir,

In producing herewith the driver namely 1) Deben Bauri (21 yrs) S/O Nitya Bauri of Vill- Anai, PS- Purulia (M), Dist- Purulia & Caretaker cum manager namely 2) Achinta @ Sambhu Mahato (30 yrs) S/O Gurupada Mahato of Vill- Jambad, PS-Purulia (M). Dist-Purulia along with seized vehicle (Tractor) Mahindra (colour-Red) Model No B275 DI TU MKMDLX Chassis No MBNABAEXPKI004753, Engine No-NKC2EEMJ0019 attached with Trolley loaded with Sand and with Seizure list, Memo of Arrest and Inspection Memo in respect of the supra persons before you.

The nub of the fact in a nutshell is that on 11.07.2020 at 07:35 hrs while I along with force 1) JC/866 Bibekanda Mahato, 2) NVF/263 Kaliram Mandi all of Purulia (M) PS left the PS for performing Day mobile duty vide Purulia (M) PS CC No 1925/2020 and GDE No 454 Dt. 11.07.2020 in PS area. During my evening mobile duty, I received a tip off at 10:45 hrs that a suspicious tractor loaded with sand was coming from Jambad village towards Bhangra More. Subsequently, I along with force proceeded towards Dubcharka Village to work out the tip off. While I along with force arrived near Dubcharka village more and found that 01 (one) tractor was proceeding towards Bhangra along Dubcharka Road. I along with force intercepted the vehicle (Tractor) Mahindra (colour-Red) Model No B275 DI TU MKMDLX Chassis No MBNABAEXPKI004753, Engine No-NKC2EEMJ0019 attached with Trolley loaded with Sand at 11:30 hrs and I found the vehicle as well as goods as identical as I received prior information. On being asked, the driver and another person (caretaker) of the said vehicle disclosed their name noted in the supra. I asked the driver and caretaker cum manager of the vehicle to produce the valid documents in respect of the vehicle as well as the loaded sand. But the drivers and caretaker cum manager of the said vehicle could not able to produce any kind of documents in respect of the Tractor and the sand. I repeatedly asked both the driver and caretaker cum manager to produce the valid paper but they stated differently in different times. The incoherent statement of the driver and caretaker cum manager purported to be a suspicious to us. It was ascertained that the driver and caretaker cum manager of the those tractor loaded the said sand in cahoots with the owner of the vehicle by illegal means for selling the same to make profit by dishonestly and they had been running a clandestine business. So it is reasoned to belief that they in cahoots with the owner of the vehicle procured the said sand form Kansai River near Anai- Jambad village side by fraudulently means or theft by any means for transporting the same to run clandestine business. So I, seized the tractor Mahindra (Colour-Red) Model No B275 DI TU MKMDLX Chassis No MBNABAEXPKI004753, Engine No-NKC2EEMJ0019 attached with Trolley loaded with Sand under proper seizure list in presence of available witnesses duly signed by them and also arrested the driver and caretaker cum manager namely 1) Deben Bauri (21 yrs) S/O Nitya Bauri of Vill- Anai, PS- Purulia (M), Dist- Purulia & Caretaker cum manager namely 2) Achinta @ Sambhu Mahato (30 yrs) S/O Gurupada Mahato of Vill- Jambad, PS-Purulia (M). Dist-Purulia after informing the ground of their arrest and issued Memo of Arrest and Inspection Memo against them. Thereafter, I brought the seized tractor to Purulia (M) PS compound.

Under the above facts and circumstances kindly take lawful action against and caretaker cum manager the drivers namely 1) Deben Bauri (21 yrs) S/O Nitya Bauri of Vill- Anai, PS- Purulia (M), Dist- Purulia & Caretaker cum manager namely 2) Achinta @ Sambhu Mahato (30 yrs) S/O Gurupada Mahato of Vill- Jambad, PS-Purulia (M). Dist-Purulia and the owners of the vehicle as they committed offence u/s 379/411/414/120B of the IPC & 21(I) (4) of Mines and Minerals (R&D) Act-1957.
