On dated 24/06/2020 in the morning my elder brother was going to his office from Purulia Town to Para Block, he has posted as a BLA in Office of the Sub-Inspector of School/ CPC, Para CLRC, Para, Purulia under School Education Department Govt. Of West Bengal, he was riding his bike Apache RTR-160, bearing No-JH09AE 9918, he was approaching Golkunda More at approximately 10.40 a.m. when suddenly and without warning an unknown Mini Pick Up Truck which was running rush and negligent coming behind him on Raghunathpur- Purulia Road and hit him the driver of the Pick-Up van could not control his vehicle he was slammed down on the pavement ahead. His bike was heavily damaged and he sustained cuts and abrasions across the left hand and severe injury in his left leg below the knee meanwhile he was ran away from the accident took place. Local people were helped him and rescued him. He immediately called to police station and informed the incident within some minutes Police arrived at the incident took place and drove him to the Deben Mahato Sadar Hospital, Purulia.
