

In producing herewith the 07 persons namely (i) Bijen Mahato (25 Yrs) s/o Ragbat Mahato, (ii) Bikash Ch. Mahato (30 Yrs) s/o Mahadev Mahato, (iii) Tarapada Mahato (50 yrs) s/o Lt. Suchand Mahato, (iv) Hemanta Mahato (25 yrs) s/o Lt. Chhutulal Mahato, (v) Paban Mahato (35 Yrs) s/o Indrajit Mahato, (vi) Jagaram Mahato (55 yrs) s/o Lt. Pelaram Mahato & (vii) Biswnu Pada Mahato (32 yrs) s/o Ragbat Mahato all of Vill- Sitalpur, PS- Purulia (M), Dist- Purulia

The fact of the case in a nut shell is that I SI SK Ismail Ali along with force namely 1) C/1479 Anup Mahato 2) C/1413 Kanailal Mandal, (iii) JC/1366 Ahid Ansary & (iv) NVF Mahanta Mahato was performing the Special Mobile duty for the implementation of Complete Lock Down in the area vide Purulia (M) PS GDE 982 dtd 23/07/2020 in consonance with C.C No 2048/2020 Dtd. 23/07/2020 as per order of superior. During my Special Mobile Duty, while I arrived at Sitalpur more at 21:25 hrs and found 07 (seven) persons noted in the supra were confabulating among themselves sitting beside the road without wearing the mask and maintaining the social distance at the complete lock down day and in consonance with the following night curfew from 22:00 hrs to 5:00 hrs. On being asked they could not give sufficient reason or satisfactory answer of their unwarranted confabulation beside the road after violating the Government order in this pandemic situation. Subsequently, they obstructed us in the discharge of our functions while I interposed to their confabulation in lieu of giving us the satisfactory answer. Consequently, it reasoned to believe that they violated the order and disobeyed the direction during this pandemic situation duly promulgated by Govt. of West Bengal vide Memo No 283-CS/2020 dtd 21/07/2020 in consonance with the earlier order 272-CS/2020 dated 30/06/2020 . Subsequently it is pertinent to say that the supra noted persons did the negligent act knowing themselves that their malignant act were likely to spread infection of the epidemic diseases which is dangerous to life themselves and others. Consequently, the supra noted persons were arrested on the spot and informed them the gourd of their arrest and issued memo of arrest in respect of them.

As the supra noted persons violated the order and disobeyed the direction during this pandemic situation duly promulgated by Govt. of West Bengal vide Memo 283-CS/2020 dtd 21/07/2020 and did the negligent act knowing themselves that their malignant act were likely to spread infection of the epidemic diseases which is dangerous to life for themselves and others and their malignant act were likely to spread infection of the epidemic diseases which is dangerous to life of themselves and others and obstructed us in the discharge of our functions so they can be booked U/S 188/269/270 of the IPC and 3 of the Epidemic Diseases Act. 1897 and read with section 51 of the Disaster management Act 2005. So a specific case may kindly be initiated against them and arranged for its investigation.
