Respected Sir,


With due to inform you that I Sri Somnath Mukherjee s/o Gouranga Mukherjee of Vill- Gangmuri, PS- Rajnagar, Dist- Birbhum to the effect that on 18.07.2020 at about 12:00 hrs while my Brother-in-law namely Papu Ganguli s/o Lt. Ramsankar Ganguli of Vill- Satgram, PS- Jamuria, Dist- Paschim Bardhman was proceeding by a vehicle (Maruti Suzuki Belono) having Reg. No WB40AQ-1957 towards Ranchi along Purulia-Barakar Road (SH-05) and reached at Lipaniya More in excessive speed and suddenly lost his control and dashed a poll due to rash and negligent driving of the said driver namely Tarak Roy s/o Tapas Roy at House No 41 Sukanta Pally near Railway Station, Durgapur, Dist- Paschim Bardhman. Subsequently my brother-in-law received bleeding injury and the vehicle was damaged.
