In producing herewith the driver namely Nebaran Mahato (29 yrs) S/O Phalari Mahato of Vill-Sindri, PS- Purulia (M), Dist- Purulia along with seized vehicle (Tractor) having bearing Eng. No-RKK2DBN0221 and Chassis No-MBNAAADAPKRK02361 and attached with Seizure list, Memo of Arrest and Inspection Memo in respect of the supra person before you.

The nub of the fact in a nutshell is that on 26.07.2020 at 11:15 hrs while I ASI Anil Ch. Gorain along with force 1) C/273 Ganesh Pal, 2) C/253 Arabinda Mallik all of Purulia (M) PS left the PS for performing special mobile duty vide Purulia (M) PS CC No 2071/2020 and GDE No 1096 Dt. 26.07.2020 in PS area. During my special mobile duty, I received a tip off at 11:35 hrs that 01 (one) suspicious tractor loaded with sand was coming from Kantabera village towards Ranchi road. Subsequently, I along with force proceeded towards Katabera village to work out the tip off. While I along with force arrived Ranchi road near Jabkadih village and found that 01 (one) tractor was proceeding towards Purulia along Ranchi Road. I along with force intercepted 01 vehicle (Tractor) having bearing Eng. No-RKK2DBN0221 and Chassis No-MBNAAADAPKRK02361 attached with Trolley is loaded with sand at 12:15 hrs and I found that the vehicle as well as goods as identical as I received prior information. On being asked, the driver of the vehicle disclosed his name. I asked the driver of the vehicle to produce the valid documents in respect of the vehicle as well as the loaded sand. But the driver of the said vehicle could not able to produce any kind of documents in respect of Tractor and the sand. I repeatedly asked the driver to produce the valid paper but he stated differently in different times. The incoherent statement of the driver purported to be a suspicious to us. It was ascertained that the drivers of the tractor loaded the said sand in cahoots with the owner of vehicle by illegal means for selling the same to make profit by dishonestly and he had been running a clandestine business. So it is reasoned to belief that the accd. in cahoots with the owner of vehicle procured the said sand form Kansai River near Kantabera village side by fraudulently means or theft by any means for transporting the same to run clandestine business. So I, seized the vehicle (Tractor) having bearing Eng. No-RKK2DBN0221 and Chassis No-MBNAAADAPKRK02361 attached with Trolley loaded with sand under proper seizure list in presence of available witnesses duly signed by them and also arrested the driver namely Nebaran Mahato (29 yrs) S/O Phalari Mahato of Vill- Sindri, PS- Purulia (M), Dist- Purulia after informing the ground of his arrest and issued Memo of Arrest against him. Thereafter, I brought the seized tractor to Purulia (M) PS compound.

Under the above facts and circumstances kindly take lawful action against the driver namely Nebaran Mahato (29 yrs) S/O Phalari Mahato of Vill- Sindri, PS- Purulia (M), Dist- Purulia and the owner of the vehicle as they committed offence u/s 379/411/414/120B of the IPC & 21(l) (4) of Mines and Minerals (R&D) Act-1957
