In producing herewith 05 (five) arrested accused persons namely (1) Abdul Mannan (19 yrs) s/o Alam Shah of Jalabasti, PO- Ghatiali, PS-Pingrajora, Dist- Bokaro, Jharkhand, (2) Sahabaz Sai (29 yrs) s/o Saidar Sai of Vill+PO- Mahal, PS-Chandankiary, Dist-Bokaro, Jharkhand, (3) Samsuddin Sai (40 years) s/o Lt. Najir Sai of Vill+PO- Mahal, PS- Chandankiary, Dist-Bokaro, Jharkhand, (4) Nasim Khan (28 yrs) s/o Latib Khan of Vill+PS- Bermo Phushra, Dist- Bokaro, Jharkhand, (5) Sk. Aktar @ Rani (23 yrs) s/o Sk. (8) One Iron made Alpine Lifter, length approx 2.5 ft, that 03.07.2020 at 23:25 hrs in course of my night mobile duty (vide Purulia (I) PS GDE No-172 dt 03.07.2020) I received secret information from a source that a gang of criminals comprising of 14/15 heads under the leadership of (1) Sk. Aktar (23 yrs) s/o Sk. Safik of Vill- Hutmura, Jaynagar, PS- Purulia(M), Dist- Purulia, being armed with deadly weapons gathered at Purulia Bus Stand near SBSTC Garage with a view to commit dacoity at Babulal Soni Jewlers, Sandeshgoli, PS-Purulia(T), Dist-Purulia.

Accordingly I informed the matter to O/C Purulia (I) PS, over RT and contacted with all night patrolling officers, briefing to all. I immediately along with source and SI Maniur Rahaman, NVF Arup Mahato, HG 1442 Shanti Kundu and other officers & forces, left to work out the information with Govt. vehicle No WB 56C 0800. At 23:45 hrs we reached at Purulia Bus Stand near SBSTC Garage, the place where the accused were assembled and preparing themselves for committing dacoity. From a distance of about 40 yards we cordoned them. Their whispering came to our knowledge regarding committing of dacoity at Babulal Soni Jewlers, Sandeshgoli, PS- Purulia(T), Dist-Purulia. We crawled nearer to them and disclose our identity and asked them to surrender; at that time, they all started to fled away, we chased them by using dragon light device. After a hot chase we could able to apprehend (1) Abdul Mannan (19 yrs) s/o Alam Shah of Jalabasti, PO- Ghatiali, PS-Pingrajora, Dist-Bokaro, Jharkhand, (2) Sahabaz Sai (29 yrs) s/o Saidar Sai of Vill+PO- Mahal, PS- Chandankiary, Dist-Bokaro, Jharkhand, (3) Samsuddin Sai (40 years) s/o Lt. Najir Sai of Vill+PO- Mahal, PS- Chandankiary, Dist- Bokaro, Jharkhand, (4) Nasim Khan (28 yrs) s/o Latib Khan of Vill+PS- Bermo Phushra, Dist- Bokaro, Jharkhand, (5) Sk. Aktar Aktar @ Rani (23 yrs) s/o Sk. Safik of Vill- Hutmura, Jaynagar, PS- Purulia(M), Dist- Purulia, as identified on interrogation. On further interrogation they stated that they along with 9/10 others were assembled there and preparing themselves for committing dacoity at Babulal Soni Jewlers, Sandeshgoli, PS- Purulia(I), Dist-Purulia. We searched the above persons and following items were recovered from their possession, as (1) One nylon rope in gray colour, length approx 30 ft. (2) One Iron rod, length approx 2.5 ft. (3) One Bamboo stick, length approx 2.5 ft. (4) One Tangy with Bamboo handler, length approx 1.5 ft. (5) One small Gaity with Iron handler (6) One Cutter with small handler, length approx 1ft. (7) One Chopper, length approx 1 ft. (8) One Iron made Alpine Lifter, length approx 2.5 ft. from their possession noted in the seizure list. On demand, they failed to give any satisfactory explanation in respect of their presence at that area in the dead hours of night with such deadly weapons. So it is crystal clearly that they were assembled in that area to commit dacoity and thereby they are liable for punishment U/S 399/402 IPC. As such at 00:15 hrs to 01:45 hrs on 04.07.2020, the above noted accused persons were arrested maintaining all guidelines of Hon'ble Supreme Court of India and seized the above articles preparing seizure list duly signed by accused persons. As no public witnesses were present at the abandoned area thus seizure list was signed by the accompanied officers and force.
