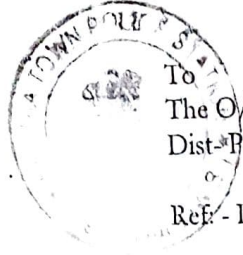


With due respect I SI Bapan Mondal, beg to submit before you that on 05.07.2020 at about 18:45 Hrs while was on performing along with Evening Patrolling mobile Duty with ASI Nayan Mondal and forces at Bhatbandh More and found following arrested persons were wandering there without Mask and detained them subsequently at the spot. On being asked the following persons could not able to give any satisfactory answer for that wandering on the road without mask. As such the following persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal circular. Moreover all the detained persons were making and circulating false alarm or warning as to disaster or its severity or magnitude, leading to panic among people and as well as the society.
