

Date , Place & time of Occurrence :- on 11.06.2020 at about 7.30 A.M.

At Complainant above noted resident.

The humble petition of the above noted complainant

begs to state as follows :-





- 1. That the complainant and the accds. No. 1 are husband and wife and their marriage was socially solemnized on 02.01.2010 however the said marriage was legally been registered on 18.04.2016 vide Certificate Sl. No. 31/2016 as per special Mariage Act and out of their said wed lock a female child has been born namely Priya Gorai now aged about 10 years old.
- That since the very inception of the marriage the accd. No. 1, tortured to the complainant both Mentally and physically as such at last on 03.5.2020 at about 10 A.M. the accd. No. (1) kicked out the complainant with his minor daughter and after that the complainant started to live peacefully at Nimtand Purulia with his minor daughter, but the accd. No. (1) did not mend her behavior and on 11.6.2020 at about 7.30 A.M. the accd. No. (1) with the above noted all accd. Persons with some ill motive reached at the complainant above noted address and they forcibly entered into his house and started brutally beating upon the complainant with bamboo sticks and iron rod and they snatched about Rs 2,00,000.- in cash after broken the box and also they snatched his minor daughter and they threatened him with dire consequences and they fled away.
- 3. That after the above incident the complainant had been to Purulia Town
 P.S. but the police advised to take shelter before Your Ld. Court to get appropriate
 Justice.
- 4. That the accd. Persons thus committed offence U/s. 323/ 324/ 379/ 447/ 448/ 506/34 I.P.C. and they should be face trial before the Ld. Court of the law.
