Sir,

With due respect I SI Subrata Sarkar, beg to submit before you that on 15.07.2020 at about 14:15 Hrs while under signed was on mobile duty, alongwith ASI Nayan Mandal and ASI Ujjal Rajak found following 14 (fourteen) persons, & 220 others unknown DYFI (Purulia District Committee under the leadership of Shri Shyamal Mahato, District Secretary) leaders and supporters, were organizing a procession from Jubilee Maidan, Purulia to Kachari More, before DM Office, Purulia under Purulia town PS area with party flag and posters without any permission even they did not maintain social distance and as well as to break the lock down system. As per Govt. circular, the political programme as well as procession irrespective of all political parties is restricted in this pandemic situation. They detained at Kachari More, before DM Office, Purulia. On being asked the following DYFI leaders and supporters could not able to give any satisfactory answer for that gathering on the road. As such the following persons violated the order during this pandemic situation. Moreover all the persons were making and circulating false alarm or warning as to disaster or its severity or magnitude, leading to panic among people and as well as the society and give provocation to the people to break public peace or to commit other offence making conspiracy. They also disobeyed the Government Order regarding recent pandemic situation for attacking of Corona virus throughout the India as well as whole World.
