LODGING OF FIRST INFORMATION REPORT (FIR) FRAUDULENT ACTIVITIES/VANDALISM ATM DISPUTED TRANSACTION

I , Pradip Kumar Singh, S/o Shri Kalidas Singh aged 37 years working as Branch Manager, State Bank of India, Purulia Town Branch and duly authorized by the Bank to file the complaint/FIR pertaining to alleged fraud perpetrated by fraudsters at SBI Purulia Town Branch ATM at 06:08 AM on 13.07.2020.

As reported by ATM Engineer and by went through CCTV footage it is found that fraudsters are targeting unguarded ATMs located at various location and modus operandi is that fraudsters may be placed external device inside dispensing slot before dispensing cash and forcefully damaged cash dispensing shutter lock and the effect of that as the shutter lock was damaged, fraudsters pick physical cash with the support of that external device but without debiting his account (in his account one debit and one credit entry) and card used for those transactions are of other bank customer. While verifying cash by custodians they found physical shortage of cash. Rs. 9500/-(Rupees Nine Thousand fire Hundred only

Therefore, we request you to start the investigation by treating the letter as complaint and apprehend the culprits and bring them to justice for misappropriation of Bank money.
