

Sir,

With due respect I SI Maniur Rahaman, beg to submit before you that on 23.07.2020 at about 11:25 Hrs while was on mobile Duty with ASI Nayan Mandal and forces vide C. No- 1744/20 dated- 23.07.2020 at Hat tola morh- Court morh and found following arrested persons were wandering there without Mask and detained them subsequently at the spot. On being asked the following persons could not able to give any satisfactory answer for that wandering on the road without mask. As such the following persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal circular. Moreover all the detained persons were making and circulating false alarm or warning as to disaster or its severity or magnitude, leading to panic among people and as well as the society.
