With due respect I SI Sk. Afruddin, beg to submit before you that on 25.07.2020 at about 17:55 Hrs while was on Holla mobile Duty with SI Sk. Afruddin and forces vide C.C. No- 1766/20 dated- 25.07.2020 at Purulia Bara Hat Road and found following arrested persons were wandering there without Mask and detained them subsequently at the spot. On being asked the following persons could not able to give any satisfactory answer for that wandering on the road without mask. As such the following persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal circular. Moreover all the detained persons were making and circulating false alarm or warning as to disaster or its severity or magnitude, leading to panic among people and as well as the society.
