Sir,

With due respect I SI Subrata Sarkar, beg to submit before you that on 27.07.2020 at about 18:55 Hrs while was on Holla mobile Duty with ASI Tapas Patra and forces vide C.C. No- 1784/20 dated- 27.07.2020 at Hattola More and found following arrested persons were wandering there without Mask and detained them subsequently at the spot. On being asked the following persons could not able to give any satisfactory answer for that wandering on the road without mask. As such the following persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal, vide Order No- 272-CS/2020 dated- 30.06.2020 nonficed extension of containment zone based lockdown. Moreover all the detained persons were making and circulating false alarm or warning as to disaster or its severity or magnitude, leading to panic among people and as well as the society. Accordingly the following persons were arrested from 19:05 Hrs. to 20:45 Hrs. after maintaining all formalities regarding arrest and brought them to P.S.
