Prayer for starting a specific case against (1) Meghnath @ Megha Dhibar (28) S/o Mihir Dhibar of village Mangalda, (2) Sanjoy Gorai @ Bumba (24) S/o Manohar Gorai of village Biltora, both Sub: of PS Raghunathpur, Dist-Purulia.

Sir,

In producing here with the arrested Accd. person namely (1) Meghnath @ Megha Dhibar (28) S/o Mihir Dhibar of village Mangalda, (2) Sanjoy Gorai @ Bumba (24) S/o Manohar Gorai of village Biltora, both of PS Raghunathpur, Dist-Purulia as disclosed by the arrested accused person along with seized articles under proper seizure list (enclosed here with) i.e. (i) Exhibit Mark-'A'-One white coloured nylon bag (ii) Exhibit Mark-'B'- One golden colour transparent plastic Jaricane along with same coloured cap containing 3984 gram (including Jaricane) of light red coloured codeine like mixture (rest mother sample after taken out Exhibit Mark "C" & "D"), (iii) Exhibit mark - 'C" 100 gram of codeine as test sample. (iv) Exhibit mark "D" 100 gram of codeine as security sample. Exhibit mark B & C were collected from mother sample which was 4184 grams (including Jaricane) of light red coloured codeine like mixture. All Exhibits are in properly sealed and labeled condition under proper seizure list.

I, SI Jayanta Kr Chakraborty of Raghunathpur PS do here by lodge this complaint as suo-mottu to the effect that today (05/07/2020) at 23:05 hrs received a secret information from my source that 02 (two) persons would be coming from Adra side and may proceed towards Raghunathpur side through Adra - Raghunathpur Pitch road with some contraband goods suspected to be narcotic substance in order to sell the same. On received such information I immediately diarized the fact in GD vide Raghunathpur PS GDE No 251 dated- 05.07.2020 and informed the matter to IC Raghunathpur PS who please directed me to proceed to work out the information. As such as per his direction I SI Jayanta Kr Chakraborty along with (i) ASI- Biman Pandey (ii) C/1057 Albinus Tirkey (iii) C/1068 Ranajit Mondal (iv) CD/14 Milan Ch. Gorai, all are Raghunathpur P.S. left at 23:30 hrs for ITI More, Raghunathpur after preparing inventory list, by Govt. Vehicle No WB 56B/4921 attached to Raghunathpur PS equipped with govt. supplied arms and ammunition, weighing machine, white paper, gala, white cloth, carbon paper, stamp pad, seal of Raghunathpur PS, envelope etc. vide Raghunathpur PS CC No. 2135/20 Dt. 05.07.2020 & Raghunathpur PS GDE No 252 dt. 05.07.2020.

At about 23:50 hrs reached near to ITI More on Adra - Raghunathpur road under Raghunathpur PS. After reaching, the said Govt. vehicle was kept in reasonable distance conducted ambushed up to 00:05 hrs on 06.07.2020. At that time found 02 (two) persons approaching on foot from Adra side with a bag towards ITI More side. While they reached closer to police party we surrounded them and focused our torch light and detained them. On asked they disclosed their identity as (1) Meghnath @ Megha Dhibar (28) S/o Mihir Dhibar of village Mangalda, (2) Sanjoy Gorai @ Bumba (24) S/o Manohar Gorai of village Biltora, both of PS Raghunathpur, Dist-Purulia. We informed them that we have specific information that they have illegal narcotic substance and they admitted that they procured and carrying codeine mixture without any valid papers and others.

In the meantime I sent C/1068 Ranajit Mondal to search for disinterested public witnesses to be witnessed during the time of search and issued notice as per NDPS Act to the detained persons in order to conduct their search by a Executive Magistrate or by any Gazetted Police Officer. They informed in writing that they have no objection if the search conducted either by any Gazatted Police Officer or by any Executive Magistrate. Accordingly I informed IC Raghunathpur PS- Insp. Sandip Chattaraj at about 00:20 hrs on 06.07.2020 regarding the whole things.

At 00:30 hrs, IC Raghunathpur PS informed me over telephone that no Executive Magistrate could be made available as such odd hours of the night, So IC himself his proceeding to the spot.

Meanwhile, at 00:45 hrs C/1068 Ranajit Mondal returned to the spot with 1) Naran Paramanik (61) S/o Lt. Kalipada Paramanik of Paschimpally, Ward No.13, PS-Raghunathpur, Dist-Purulia and 2) Sukumar Gorai S/o Bhikuram Gorai of Tantipara, Ward No 3, PS - Raghunathpur, Dist - Purulia as disinterested witnesses.

At about 00:55 hrs Insp Sandip Chattaraj, IC Raghunathpur PS reached there and I narrated him about the development. He disclosed his identity before the detained persons and asked me to issue notice to the detained persons, offering them to search the available police personnel present there as well as the public witness present there, but they showed no interest and refused to conduct any search of the police personal and public witness in writing.

As per direction of IC Raghunathpur PS, I conducted search of (1) Meghnath @ Megha Dhibar (28) S/o Mihir Dhibar of village Mangalda, (2) Sanjoy Gorai @ Bumba (24) S/o Manohar Gorai of village Biltora, both of PS Raghunathpur, Dist-Purulia in between 01:05 hrs to 01:45 hrs.

During search I recovered one white colour nylon bag in which found one golden colour transparent plastic Jaricane along with same coloured cap containing light red colored liquid. On interrogation they admitted that it is the codeine mixture and they are habituated in dealing of such clandestine illegal business of Codeine for commercial purpose for their wrongful gain, knowing the same is a punishable offence. On demand they failed to produce any documents or justify regarding the storage of huge quantity of contraband codeine mixture. According to the direction of IC Raghunathpur P.S. I weighed the Jaricane and it resulted in 4184 grams including Jaricane in weighing machine. On reasonable belief, an offence has been committed in respect of recovered liquid substance believe to be codeine mixture from which 100 gram each were taken in 02 (two) plastic bottles as test sample and security sample from mother sample. The said articles were seized U/S 43 of NDPS act. 1985 under proper seizure list duly signed by the witnesses as well as the accused persons. I also supplied a copy of seizure list to the accused persons. I arrested the detained persons maintaining all formalities. The seized bottles were properly labeled and sealed.

In between 01:55 hrs. to 02:05 hrs. I prepared another inventory list containing weighing machine, some white paper, used gala, rest white cloth, used carbon paper, stamp pad, seal, burnt candle, four empty small bottles, one Jaricane and two small bottles (the Jaricane consists of 3984 gram and other two bottles contains 100 gram each of seized codeine mixture) in presence of witnesses and accused persons. The entire process was supervised and directed by I/C Raghunathpur PS, Sri Sandip Chattaraj.

The accused persons are liable for prosecution U/S- 21(c) /29 of NDPS Act. 1985 as amended up to date.

Under the above fact and circumstances I like to lodge an FIR against (1) Meghnath @ Megha Dhibar (28) S/o Mihir Dhibar of village Mangalda, (2) Sanjoy Gorai @ Bumba (24) S/o Manohar Gorai of village Biltora, both of PS Raghunathpur, Dist-Purulia U/S- 21 (c) /29 of NDPS Act. 1985 as amended up to date and arrange for its investigation.
