With due respect I beg to submit before you that on 06/07/2020 at about 19:25 hrs. while I, SI Debabrata Chakraborty along with force were engaged on area round duty in Raghunathpur Town area and found the following persons were moving in Raghunathpur Town near to Raghunathpur New Bus Stand without wearing Mask, as such I detained them on that spot and immediately took their picture in my personal mobile phone as a token of prove, after narrating them the ground of taking picture. On being asked the following persons could not able to give any satisfactory answer for that not wearing Mask in this pandemic situation. As such the following persons violated the order during the pandemic situation duly promulgated by Govt. of WB in c/w Corona virus/Covid-19. Moreover, both the detained persons were making and circulating false alarm or warning as to disaster or its severity or magnitude, leading to panic among people and as well as the society. Accordingly the following persons were arrested after maintaining all the formalities regarding their arrest and brought them to PS.

1. Biltu Rajak (25) S/o Goutam Rajak of Dhoba-Para, Ward No. -2, PS Raghunathpur, Dist-Purulia
2. Pushu Bauri (38) S/o Late Rupa Bauri of Bhakat-Para, Ward No. 2, Raghunathpur, Dist-Purulia

Hence it is prayed before you that above mentioned persons may kindly be prosecuted under proper section of law.
