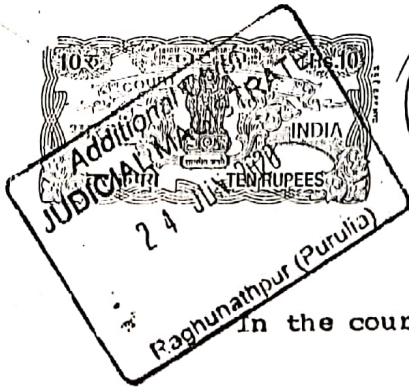

3. That accused persons are very much rough, rude in nature and all time trying to do mischief with the person and property of the complainant.

4. That with a view to take forcible possession of the Property mentioned above of the complainant all the accused with their ulterior motive making an unlawful assembly having armed with " Gaints" , Axe, Rod and Lathi trespassed into the property of the complainant and tried to demolish some portion of the boundary wall of the complt in which complaint raised protest whereupon Accd. persons came to be red in teeth and assaulted the complaint and also drove outhim form there^{and} rushed him upto his welling house nearby with an intention to cause grievous injury with deadly weapon. 6. That family members of the complainant also became astonished and spell^{bound} ~~bound~~ seeking such aggravated notoriety of the accd.persons, they were also threatend by the accd. persons with dire consequence . Unless they restrain the complt

However complaint informed such incident to the local police station at Raghunathpur on ^{21/2}25/02/2020 with a written complaint which came to be inf~~or~~tu~~ous~~ there after complain^{ant} sent his grievance to the Superintendent of Police Purulia through regd.post^{on 5/3/20} but very unfortunate to state that also went negative .

8. That finding no other alternative complaint seeking seeks his remedy before Id.court as per provision of law.
