

- That complainant and accused person are well known to each other.
- That complainant is the owner of an area 22 dec. within R.S.plot No. 229 of mouza- Telkupi, which is under exclusive possession of thecomplainant since long with proper boundary wall without concernany others.

- are very much rude in nature and all time trying to do mischief with the person and property of the complainant.
- That with a view to take forcible possession of the Property mentioned above of the complainant all the accused with their ulterior motive making an unlawful assembly having armed with " Gaints" , Axe, Rod and Lathi tresspassed into the property of the complainant and tried to demolish some portion of the boundary wall of the complt in which complaint raised protest whereupon Accd. persons came to be red in teeth and assaulted the complaint and also drove outhin form there rushed him upto his welling house nearby with an intention to campagrieveous injury with deadly weapon. And Acced persons also tresspessed into the house of complainant with aforesaid deadly weapons and threatend the complaint " AYTAT (212 Chiral CHESS LING 2005) (013 5/03-61) (16 (24, C.F. Accd. persons left thehouse of the complaint also giving an threat with dire consequence.

- That family members of the complainant also became astonished and spell, betned seeking such aggravated notoriohty of the accd. persons, they were also threatend by the accd. persons with dires consequence . Unless they restrain the complt

from entering his land mentioned above.

- 7. That being panic striken complaint could not came out from his house due to life threatening of the Accd persons. However complaint informed such incident to the local police station at Raghunathpur on 126 02/2020 with a written complaint which came to be informations there after complaint sent his grievance to the superintendant of Police Purulia through regd.post but very unfortunate to state that also went negative.
- 8. That finding no other alternatibe complaint seeking seeks his remedy before Ld.court as per provision of law.

Under such circumstances it is respectfully prayed that O/C Raghunathpur P.S.may immax kindly be direfed to came investigation into the matter after treating the same as F.I.R.
