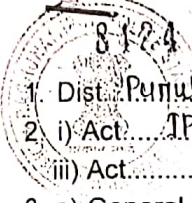

On being asked the following persons could not able to give any satisfactory answer for that not wearing Mask in this pandemic situation. As such the following persons violated the order during the pandemic situation duly promulgated by Govt. of WB in c/w Corona virus/Covid-19. Moreover, both the detained persons were making and circulating false alarm or warning as to disaster or its severity or magnitude, leading to panic among people and as well as the society. Accordingly the following persons were arrested after maintaining all the formalities regarding their arrest and brought them to PS.
