Sub: Request for lodging FIR against arrested accused persons.

Sir,

With due respect I beg to submit before you that on 19/07/2020 at about 13:45 hrs. while I, SI Subhash Malik along with force were engaged on area round duty in Raghunathpur Town area and found the following persons were moving at Blockdanga, Raghunathpur under Raghunathpur PS without wearing Mask, as such I detained them on that spot and immediately took their picture in my personal mobile phone as a token of prove, after narrating them the ground of taking picture. On being asked the following persons could not able to give any satisfactory answer for that not wearing Mask in this pandemic situation. As such the following persons violated the order during the pandemic situation duly promulgated by Govt. of WB in c/w Corona virus/Covid-19. Moreover, all the detained persons were making and circulating false alarm or warning as to disaster or its severity or magnitude, leading to panic among people and as well as the society. Accordingly the following persons were arrested after maintaining all the formalities regarding their arrest and brought them to PS.

1. Samir Paramanik (40) S/o Ajit Paramanik of Maligoli Para, Ward No 3, PS – Raghunathpur, Dist.- Purulia
2. Ranjit Bagdi (38) S/o Jharu Bagdi of Addapara, Ward No 9, PS – Raghunathpur, Dist.- Purulia
3. Sukumar Murmu (35) S/o Fulchand Murmu of Vill.- Bundla, PS – Raghunathpur, Dist.- Purulia
4. Kanan Majee (28) S/o Biswanath Majee of Vill.- Dhaniardanga, PS – Raghunathpur, Dist.- Purulia
5. Nehal Khan (33) S/o Jamal Khan of Para Bazar, PS – Para, Dist.- Purulia
6. Sk Hafijul (45) S/o Sk Monkir of Vill.- Lalurdih, PS – Raghunathpur, Dist.- Purulia

Hence it is prayed before you that a specific case may kindly be lodged against the above mentioned persons under proper section of law.
