Sir.

I, SI Bangshi Badan Mondal of Raghunathpur PS returned to PS with force and brought under seizure 1) One TVS Apachi Motor Cycle having No- WB82B/8399 2) One Hero Achiever Motor Cycle having No- WB 82C/2966 3) One Honda S.P. Shine Motor Cycle having No- WB 82C/5967 4) One Honda Dream Neo Motor Cycle having No- WB 82C/4597. 5) One Avenger Motor Cycle having Chasis No- MD2B57CY3KCJ34307, Engine No – PDYCKJ15592 6) One Glamour Motor Cycle having No- WB 82B/5092 7) One Hero Honda Super Splendor having No – WB 56E/1667 lodged this complaint against (1) Debraj Bauri (20) S/o Bikram Bauri of Chandagoria, Ward No 8, PS – Raghunathpur, Dist.- Purulia. During evening mobile duty as per direction we were engaged for implementation of Govt. rules regarding Lockdown and disaster management plan. As per district order from 18.15 Hrs. myself with force was performing Naka checking at Traffic more under Raghunathpur P.S. above noted Motor cycles were detained as they were moving aimlessly and creating Halla without wearing mask in their face. I examined detained persons and during examination they disclosed their identity as noted above but they did not give proper reason why they came out from house and reached there. So, there is every reason to believe that the riders of those Motorcycles came out from their home and moving aimlessly or making fun and they did not came for emergency purpose. Though lockdown is going on throughout the District of Purulia in view of Pandemic of COVID-19 outbreak vide Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020 and 10/04/2020 for complete restriction measure. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No- H & F W/120/20 dated 22.03.2020 which is extended till 31.07.2020. Therefore they disobeyed Govt. order and committed negligent act likely to spread infection of diseases dangerous to life and violated Quarantine rule. So, I seized those Motor cycles with proper seizure list. I also arrested above noted accd. persons maintaining all formalities of arrest and later on released on bail considering present situation of epidemic COVID-19.

Therefore, I pray a specific case may kindly be lodge against above noted 11 (Eleven) arrested accd. persons and owners of seized motorcycles as they disobey Govt. order and committed negligent Act likely to spread infection of diseases dangerous to life and violated Quarantine rule U/S 188/269/270/271 IPC and 51(b) Disaster Management Act, 2005 and arrange for investigation.
