Sir.

With due respect I SI Subhash Malik of Raghunathpur PS beg to state that I have been detailed for evening mobile duty along with force vide CC No 1459/2020 dated- 18.07.2020 and Raghunathpur PS GDE No 899 dated- 18.07.2020. At about 19:35 hrs received information from duty office, Raghunathpur PS that some persons are gathered at Chelliyama market and create nuisance which may disturb peace and tranquility in that area.

After received such information I informed the matter to I/C Raghunathpur PS and as per order of I/C Raghunathpur I along with force moved towards Chelliyama Market at about 20:05 hrs. I along with force reached at Chelliyama Market and found 30/35 persons are gathered there. Police party intervened at once and disperse the mob from that place During enquiry it could be learnt that when one Maruti Car of Dubra village with 03 (three) passengers was coming from Bamarrah side towards Dubra side, cross the narrow Chelliyama market road at that time a hot altercation took place among the passengers of Maruti Car and some shop owners of the Chelliyama market. Some shop owners restrained the vehicle and scuffling took place among them, both the parties received injuries on their persons. They also threatened each other and used filthy languages as well as intentionally insults and thereby gives provocation with intent to provoke caused them to break breach of the peace.

Tackle the entire situation of the area, I therefore pray before you that necessary legal action may kindly be taken as per law against 03 (three) unknown persons of Dubra village under Para PS and 10/15 unknown persons of Chelliyama market.
