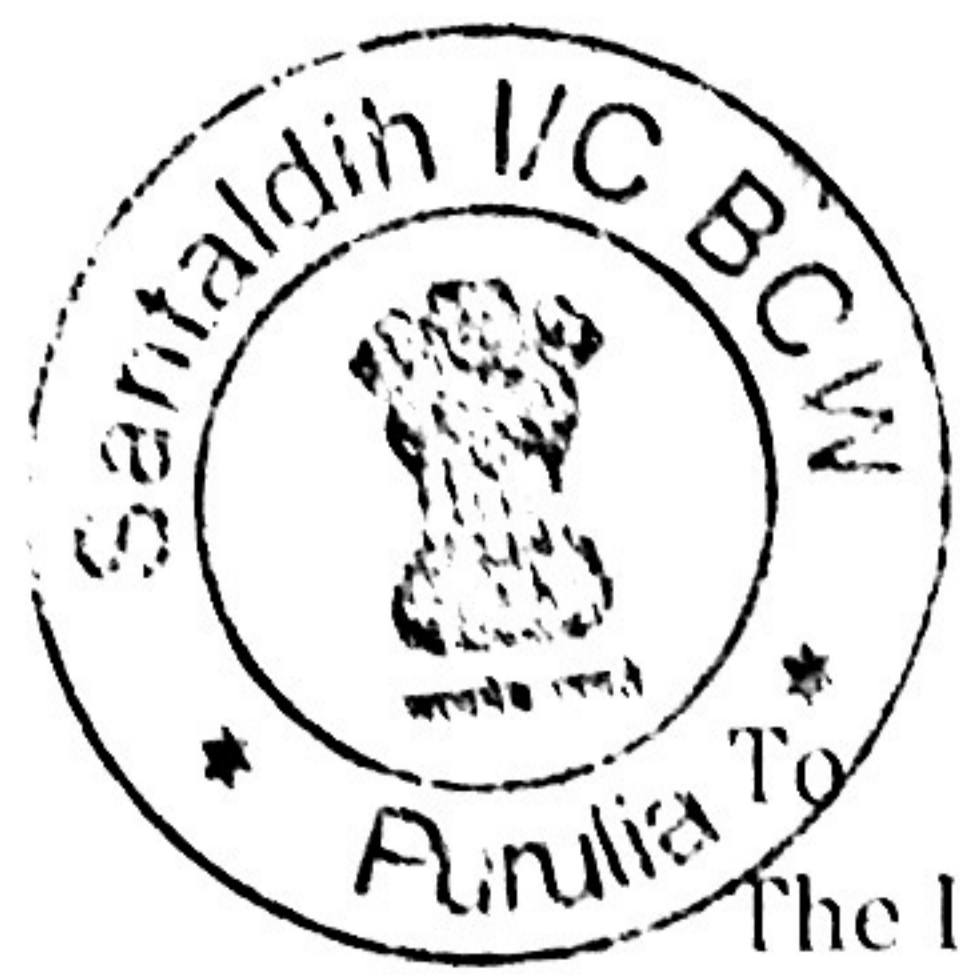

Sir,

With due respect, I, SI Dipankar Biswas of Santaldih Investigation Centre, beg to submit that today (23/07/2020) at about 15:25, while myself along with force were performing special mobile duty and found the above noted persons were assembled aimlessly at Cinematola Morh area under Santaldih P.S. Police party detained them at Cinematola Morh and being asked they could not able to give any satisfactory answer for their presence at said place. Though lockdown is going on throughout the district of Purulia in view of Pandemic of COVID - 19 outbreak. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Memo No. 283 - CS/2020, dated 21/07/2020. Moreover, all the detained persons were refused to comply the direction given by the State Govt. to combat the rapidity of COVID - 19 pandemic. All the accused persons also tried negligently to spread infection of disease dangerous to life. Accordingly, they were arrested after maintaining all formalities regarding arrest and prepared arrest memos and brought them to PS.

Under above circumstances, I, therefore, pray, that a case U/S 188/269/270/34 IPC & Read with section 51 of Pandemic Disaster Management Act, 2005 may kindly be initiated against (1) Durjodhan Kumbhakar (18) S/O Nirmal Kumbhakar of Ichhar, (2) Subhas Bauri (27) S/O Bashu Bauri of Simulhir, (3) Barun Mahato (26) S/O Adhibash Mahato of Parashya, (4) Prahlad Paramanik (49) S/O Kashinath Paramanik of Poradih, (5) Dipak Gope (40) S/O Bhim Gope of Bogra, (6) Biswanath Mahato (25) S/O Sitaram Mahato of Santaldih Basti, (7) Thakurlal Mahata (36) S/O Lt.
