In producing herewith arrested accused persons (1) Swapan Roy (30) S/O Shantiram Roy of Jhapra, (2) Rakhahari Roy (28) S/O Lt. Bharat Roy of Jhapra, (3) Subhas Roy (23) S/O Gour Roy of Jhapra, (4) Sk. Siraj Darji (28) S/O Sk. Fatik Darji of Sankra (Hariharpur), (5) Sk. Habibul Darji (28) S/O Sk. Kalu Darji of Sankra (Hariharpur), (6) Najibul Darji (27) S/O Kalu Darji of Sankra (Hariharpur) all of PS - Para, Dist. - Purulia, (7) Juyel Edwin Dosh (47) S/O Raymond Albert Dosh of Pathardih Coal Washer near Sindri block halt, PS - Pathardih, Dist. I, SI Partha Pratim Chakraborty of Santalih PS, beg to submit that today (25/07/2020) at about 15:25 hrs, while myself along with force were performing special mobile duty and found the above noted persons were moving aimlessly at Ragnathpur - Chandankiyari road near Paharigora crossing under Santalih P.S. I along with force detained them at Paharigora crossing and being asked they could not able to give any satisfactory answer for their presence at that place. Though lockdown is going on throughout the district of Purulia in view of Pandemic of COVID - 19 outbreak. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Memo No. 283 - CS/2020, dated 21/07/2020. Moreover, all the detained persons were refused to comply the direction given by the State Govt. to combat the rapidity of COVID - 19 pandemic. All the accused persons also tried negligently to spread infection of disease dangerous to life. Accordingly, they were arrested after maintaining all legal formalities regarding arrest and prepared arrest memos and brought them to PS.

Under above circumstances, I, therefore, pray, that a case U/S 188/269/270/34 IPC & Read with section 51 of Pandemic Disaster Management Act, 2005 may kindly be initiated against (1) Swapan Roy (30) S/O Shantiram Roy of Jhapra, (2) Rakhahari Roy (28) S/O Lt. Bharat Roy of Jhapra, (3) Subhas Roy (23) S/O Gour Roy of Jhapra, (4) Sk. Siraj Darji (28) S/O Sk. Fatik Darji of Sankra (Hariharpur), (5) Sk. Habibul Darji (28) S/O Sk.
