Sir,

I, SI Biswarup Roy S/O Shri Jitendra Nath Roy of Bahadurpur P.S Jamuria, Dist. Paschim Bardhaman now posted at Santuri PS, Dist- Purulia do hereby lodge a written complaint against (1) Soumin SK( 19 yrs.) S/O Sk. Sobrat of Vill. Bero, Bansgram, P.S Raghunathpur, Dist-Purulia, driver of Auto bearing Reg. No. JH10AH/2367 and passenger namely (2) Fatik Gorai (65) S/O Late Nunaram Gorai of Jhankamore P.S- Saltora, Dist. Bankura to the effect that today on 04.07.2020 while I along with C/233 Upananda Das & H.G 1428 Dipankar Hansda both of Santuri PS as per direction engaged in special mobile duty within Santuri PS area, reference Santuri P.S G.D.E No. 133 dtd. 04.07.2020 and Spl. CC No- 16/20 dated 04.07.2020 for implementation of Government rules regarding lockdown Disaster Management Plan. While we proceeding towards Rambhattadiah More from Marbedia side under Santuri P.S jurisdiction and reached in front of Santuri Kali Mandir through Raghunathpur- Saltora Road(SH-08) at about 13:05 hrs. found that one Auto driver of Auto bearing Reg. No. JH10AH/2367 namely Soumin SK( 19 yrs.) S/O Sk. Sobrat of Vill. Bero, Bansgram, P.S Raghunathpur, Dist-Purulia is carrying 04 (Four) passengers out of which one passenger namely Fatik Gorai(65) S/O Late Nunaram Gorai of Jhankamore(Majpara) P.S- Saltora, Dist. Bankura were without wearing a mask which violates the compliance of norms of wearing of mask during this pandemic situation. I took photograph of the aforesaid Auto with driver and passengers having without mask in presence of co-passengers with mask and others.

So, there is every reason to believe that the above noted persons were proceeding without wearing a mask which violates the compliance of norms of wearing of mask during this pandemic situation and committed negligent act likely to spread infection of diseases dangerous to life and violated Government rule.

Therefore, I pray a specific case may kindly be started against accused (1) Soumin SK.( 19 yrs.) S/O Sk. Sobrat of Vill. Bero, Bansgram, P.S Raghunathpur, Dist-Purulia, driver of Auto bearing Reg. No. JH10AH/2367 and passenger namely (2) Fatik Gorai(65) S/O Late Nunaram Gorai of Jhankamore P.S- Saltora, Dist. Bankura U/S- 188 IPC and 51 (1) (b) Disaster Management Act, 2005 as he disobeyed Govt. order and committed negligent Act likely to spread infection of diseases dangerous to life and violated Government rule and arrange for its investigation.
