Sir,

In producing herewith one arrested accused person namely Sadhan Das (54) S/O Late Dasarath Das of Krishnapur, P.S Santuri, Dist. Purulia and do hereby lodge a written complaint against him to the effect that today on 13.07.2020 evening time when I, SI Gopal Ch. Man S/O Shri Dhirendranath Man of Gopinathpur P.S Beliatore, Dist. Bankura now posted at Santuri PS, Dist- Purulia along with C/1485 Swarup Nandi and NVF 426 Moral Besra both of Santuri PS as per direction engaged in special mobile duty within Santuri PS area, reference Santuri P.S G.D.E No. 652 dtd. 13.07. 2020 and C.C No- 2526 dated 13.07.2020 for implementation of Government rules regarding lockdown Disaster Management Plan. While we proceeding towards Muradi Station Bazar under Santuri P.S from Ramchandrapur village side and reached in front of tea shop of the above noted person at about 19:05 hrs. found that the said person was selling articles to customers without wearing a face mask which violates the compliance of norms of wearing of mask during this pandemic situation. I took photograph of the aforesaid person without wearing mask with front view of his shop in presence of witness namely Bimal Paramanik S/O Late Gorachand Paramanik of Sakra, P.S Para, Dist. Purulia A/P Krishnapur, P.S Santuri, Dist. Purulia.

So, there is every reason to believe that the above noted person was selling commodities without wearing a mask which violates the compliance of norms of wearing of mask during this pandemic situation and committed negligent act likely to spread infection of diseases dangerous to life and violated Government rule. I have arrested him maintaining all legal formalities as well as notifying the ground of arrest. Informed his family members through local people.

Therefore, I pray a specific case may kindly be started against accused Sadhan Das (54) S/O Late Dasarath Das of Krishnapur, P.S Santuri, Dist. Purulia u/s 188 IPC and 51 (1) (b) Disaster Management Act, 2005 as he refuses to comply the direction given by Govt. and committed negligent Act likely to spread infection of diseases dangerous to life and violated Government rule and arrange for its investigation.
