Sir,

I, SI Biswarup Roy, S/O- Shri Jitendranath Roy of Bahadurpur P.S Jamuria, Dist-Paschim Bardhaman now posted at Santuri PS, Dist-Purulia do hereby produce one Md Motiullah (50), S/O-Md Sanaullah of Sashpur, P.S Santuri, Dist. Purulia with all connected papers and lodge a written complaint against him to the effect that today on 15.07.2020 evening time while I along with ASI Ajay Mukhopadhaya, C/233 Upananda Das and C/1154 Jagannath Jha all of Santuri PS as per direction engaged in special mobile duty within Santuri PS area, reference Santuri P.S G.D.E No. 731 dtd. 15.07. 2020 and C.C No- 2548 dated 15.07.2020 for implementation of Government rules regarding lockdown Disaster Management Plan. While we proceeding towards Madhukunda Station Bazar under Santuri P.S and reached in front of the shop of the above noted person at about 19:15 hrs. found that the said person was selling articles to customers without wearing a face mask which violates the norms of wearing of mask during this pandemic situation. By seeing the police party all customer fled away very suddenly. I took photograph of the aforesaid person without wearing mask with front view of his shop.

So, there is every reason to believe that the above noted person was selling commodities without wearing a mask which violates the compliance of norms of wearing of mask during this pandemic situation and committed negligent act likely to spread infection of diseases dangerous to life and violated Government rule. I have arrested him maintaining all legal formalities as well as notifying the ground of arrest. Informed his family members through local people.

Therefore, I pray a specific case may kindly be started against accused Md Motiullah (50), S/O- Md Sanaullah of Sashpur, P.S Santuri, Dist. Purulia U/S- 188 IPC and 51 (b) Disaster Management Act, 2005 as he refuses to comply the direction given by Govt. and committed negligent Act likely to spread infection of diseases dangerous to life and violated Government rule and arrange for its investigation.
