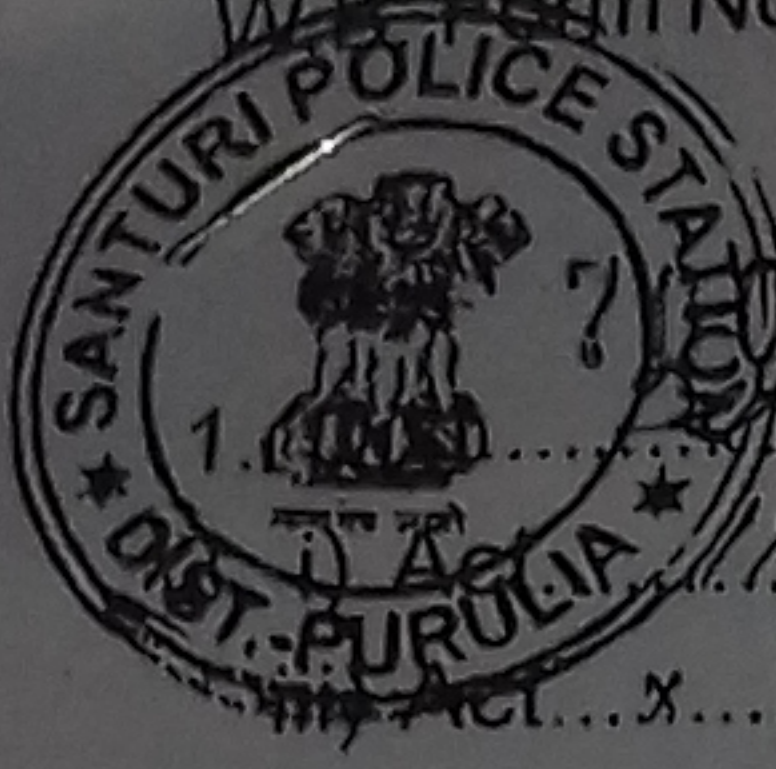

Sir,

I, SI Gopal Chandra Man S/O Shri Dhirendranath Man of Voll. Gopinathpur, P.S Beliatore, Dist. Bankura do hereby produce (1) Ananda Dome(40) S/O Kharu Dome of Kalipahari P.S Santuri, Dist. Purulia ,(2) Mantu Mahato(43) S/O Kapinda Mahato of Vill. Marbedia P.S Santuri, Dist. Purulia (3) Shaheb Dhibar(18) S/O Nimai Dhibar of Vill. Tiluri,P.S Saltora, Dist. Bankura (4) Suman Dhibar(25) S/O Kamaksha Dhibar of do (5) Bharat Paramanik(30) S/O Late Jogeswar Paramanik of Vill. Santuri, P.s Santuri, Dist. Purulia(6) Raju Kisku (30) S/O Naresh Kisku of Vill. Purulia do hereby lodge a written complaint against them, to the effect that today on 25.07.2020 while I along with C/1154 Jagannath Jha of Santuri PS as per direction engaged in night mobile duty within Santuri PS area, (Reference Santuri P.S G.D.E No. 1156 dtd. 24.07.2020 vide C.C. No. 2685 dtd. 24.07.2020 for implementation of Government rules regarding lockdown of Disaster Management Plan. On 25.07.2020 morning during the day of Lock down while we returning from Marbedia side under Santuri P.S jurisdiction and reached Santuri Bazar through Raghunathpur- Saltora Road (SH-08) at about 07:45 hrs. found that the above noted 07(seven) persons were gossiping near Santuri - Garshika More without wearing a mask and maintaining social distancing which violates the compliance of norms of wearing of mask and maintaining social distancing during this pandemic situation in c/w COVID-19. So, there is every reason to believe that the above noted persons were moving without wearing a mask and maintaining social distancing which violates the compliance of norms of wearing of mask during this pandemic situation and committed negligent act likely to spread infection of diseases dangerous to life and violated Government rule. I have arrested them maintaining all legal formalities as well as notifying the ground of arrest and informed their family members through local people.

Therefore, I pray a specific case may kindly be started against accused (1) Ananda Dome(40) S/O Kharu Dome of Kalipahari P.S Santuri, Dist. Purulia ,(2) Mantu Mahato(43) S/O Kapinda Mahato of Vill. Marbedia P.S Santuri, Dist. Purulia (3) Shaheb Dhibar(18) S/O Nimai Dhibar of Vill. Tiluri,P.S Saltora, Dist. Bankura (4) Suman Dhibar(25) S/O Kamaksha Dhibar of do (5) Bharat Paramanik(30) S/O Late Jogeswar Paramanik of Vill. Santuri, P.s Santuri, Dist. Purulia(6) Raju Kisku (30) S/O Naresh Kisku of Vill. Chhatapathar, P.S Santuri, Dist. Purulia (7) UdayHari(40) S/O Goutam Hari of Vill. Garshika, P.S Santuri, Dist. Purulia U/S- 188/34 IPC and 51 (b) Disaster Management Act, 2005 as they disobeyed Govt. order and committed negligent Act likely to spread infection of diseases dangerous to life and violated Government rule and arrange for its investigation.
