Sir,

I, SI Biswarup Roy S/O Shri Jitendra Nath Roy of Bahadurpur P.S Jamuria, Dist. Paschim Bardhaman now posted at Santuri PS, Dist- Purulia do hereby lodge a written complaint against (1) Fulchand Mandi (27 yrs) S/O-Lt. Rabidas Mandi of Vill-Poradiha (Puranopara), PS-Santuri, Dist-Purulia, (2) Badyanath Hansda (27 yrs) S/O- Lt. Rabi Hansda of Vill-Poradiha (Puranopara), PS-Santuri, Dist-Purulia and (3) Laxmikanta Mandi (30 yrs) S/O-Lt. Rabidas Mandi of Vill-Poradiha, PS-Santuri, Dist-Purulia to the effect that today on 18.07.2020 while I along with C/1485 Swarup Nandi & NVF/960 Rajeev Sing Sardar both of Santuri PS as per direction engaged in special mobile duty within Santuri PS area, reference Santuri P.S G.D.E No. 876 dtd. 18.07.2020 and CC No- 2596/20 dated 18.07.2020 for implementation of Government rules regarding lockdown Disaster Management Plan. While we proceeding towards Rambhattadih More from Marbedia side under Santuri P.S jurisdiction and reached at Santuri Bazar through Raghunathpur- Saltora Road (SH-08) at about 18:35 hrs. found that the above noted 03 (Three) persons were gossiping near Santuri Morh without wearing a mask and maintaining social distancing which violates the compliance of norms of wearing of mask and maintaining social distancing during this pandemic situation. I took photograph of the aforesaid persons without wearing mask and maintaining social distancing.

So, there is every reason to believe that the above noted persons were proceeding without wearing a mask and maintaining social distancing which violates the compliance of norms of wearing of mask during this pandemic situation and committed negligent act likely to spread infection of diseases dangerous to life and violated Government rule.

Therefore, I pray a specific case may kindly be started against accused ((1) Fulchand Mandi (27 yrs) S/O-Lt. Rabidas Mandi of Vill-Poradiha (Puranopara), PS-Santuri, Dist-Purulia, (2) Badyanath Hansda (27 yrs) S/O- Lt. Rabi Hansda of Vill-Poradiha (Puranopara), PS-Santuri, Dist-Purulia and (3) Laxmikanta Mandi (30 yrs) S/O-Lt. Rabidas Mandi of Vill-Poradiha, PS-Santuri, Dist-Purulia, U/S- 188/34 IPC and 51 (b) Disaster Management Act, 2005 as he disobeyed Govt. order and committed negligent Act likely to spread infection of diseases dangerous to life and violated Government rule and arrange for its investigation.
