

Lakhiram Hembram of Salberia, PS-Santuri, Dist-Purulia, (13) Rabidas Baskey (50 yrs) S/O-Manglu Baskey of Kherat, PS-Santuri, Dist-Purulia and do hereby lodge a written complaint against them, to the effect that today on 19.07.2020 while I along with C/1485 Swarup Nandi, C/1271 Tapas Pandit, JC/1277 Nabakanta Singh & NVF/131 Jahan Murmu all of Santuri PS as per direction engaged in special mobile duty within Santuri PS area, (Reference Santuri P.S G.D.E No. 907 dtd. 19.07.2020 and CC No- 2604/20 dated 19.07.2020) for implementation of Government rules regarding lockdown of Disaster Management Plan. While we proceeding towards Rambhattadi More from Marbedia side under Santuri P.S jurisdiction and reached at Sadhusaltora Bazar through Raghunathpur- Saltora Road (SH-08) at about 17:45 hrs. found that the above noted 13 (Thirteen) persons were gossiping near Sadhusaltora Bazar without wearing a mask and maintaining social distancing which violates the compliance of norms of wearing of mask and maintaining social distancing during this pandemic situation.

So, there is every reason to believe that the above noted persons were proceeding without wearing a mask and maintaining social distancing which violates the compliance of norms of wearing of mask during this pandemic situation and committed negligent act likely to spread infection of diseases dangerous to life and violated Government rule. I have arrested them maintaining all legal formalities as well as notifying the ground of arrest .Informed their family members through local people.
