In producing herewith the arrested accd. Person namely Sukdeb Ojha (27) s/o Sunil Ojha of Vill- Palanja, P.O- Tanashi, PS- Joypur, Dist- Purulia along with seized offending new motor cycle (Hero Passion X Pro) bearing Engine No- JA06ETKGE08550 and Chassis No - MBLJAW11XKGF00210 attached with Seizure List and Memo of Arrest with check list in respect of the supra person before you.

The nub of the fact in a nutshell is that on 22.07.2020 at 08:25 hrs while I along with i) JC/1505 Bipattaran Seth and ii) NVF/940 Bhairab Mahato both of Tamna PS left Tamna P.S to perform morning mobile duty vide Tamna P.S C.C No- 107/20 and GDE No- 634 dated 22.07.2020 in Tamna P.S area. During my morning mobile duty as per your direction I along with force arrived at near Sainik School and started Naka checking. During Naka checking duty at about 12.30 hrs one new motor cycle (Hero Passion X Pro) bearing Engine No- JA06ETKGE08550 and Chassis No - MBLJAW11XKGF00210 without number plate was coming from Chas more side towards Purulia along Ranchi road with high speed and dashed NVF/940 Bhairab Mahato due to rash and negligent driving. As a result he received bleeding injury on his head and shifted him to Deben Mahato Purulia Govt. Medical College and Hospital, Purulia for treatment by our Govt. vehicle. In the mean time the said arrested person tried to fled away with his motor cycle but we managed to apprehend him with the help of local people. I seized the offending new motor cycle (Hero Passion X Pro) bearing Engine No- JA06ETKGE08550 and Chassis No - MBLJAW11XKGF00210 under proper Seizure List in presence of available witnesses duly signed by them and also taken the driver of said motor cycle namely Sukdeb Ojha (27) s/o Sunil Ojha of Vill- Palanja, P.O- Tanashi, PS- Joypur, Dist- Purulia into police custody after issuing proper Memo of Arrest with check list. I observed all formalities regarding arrest and informed him about his ground of arrest. I brought the said seized motor cycle along with arrested driver of said motor cycle to Tamna P.S.

Under the above facts and circumstances, kindly take lawful action against the driver of offending new motor cycle (Hero Passion X Pro) bearing Engine No- JA06ETKGE08550 and Chassis No - MBLJAW11XKGF00210, namely Sukdeb Ojha (27) s/o Sunil Ojha of Vill- Palanja, P.O- Tanashi, PS- Joypur, Dist- Purulia as he committed offence u/s - 279/338 of the IPC.
