Respected Sir,

I Ganga Prasad Keshari (55) s/o Lt.
R.L. Prasad of Panchudanga, Adra beg to
inform you that on 14/08/2020 at 2 PM.
I was at my home. At that time Raja
Keshari & Raina Keshari both s/o Lt.
R.L. Prasad of Panchudanga, Adra come
at my house premises for a party and
assaulted me by bricks and bat.
At that time my son BIKKI Keshari
came at the spot to rescue me after
hearing my screaming. At that time
Raja Keshari assaulted my son in his
head by an axe which was lying
there, then he became unconscious
from that and fall down. They
threaten us and left our house.
Later my son shifted to Rajgurunagar
S.S. Hospital and got 4-5 stitches
on his head.
