Smt. Litton Basu who wrongfully restraint as well as wrongfully confined me and my old aged ailing wife for the purpose of extorting our properties.

Sir, I, Sri Niranjan Kumar Basu, aged about 90 years old, son of late Sri Nirendra hath Basu residing at Mwe Coloney Adra hereby state that I filed an application as per provisions of Maintenance and Welfare of Parents and Senior Citizens Act before the Divisional Officer, Raghunathpur, Purulia on 24th July, 2020 through Email and subsequently hard copy of the said application was filed on 03.08.20. The said application is attached herewith for your ready reference.

The above mentioned Smt. Litton Basu along with some anti-socials wrongfully confined me and my wife aged about 80 years old and locked our house from the four corner entrance of the house. Smt. Litton Basu in a loud voice uttered that she will set fire the house and kill us and abused us in most filthy languages. At that time in usual way my daughter, Smt. Soma Dey of Santragachi, Howrah talked to us over mobile phone and heard her reckless uttering and after hearing the said attitude of Smt. Litton Basu we felt insulted and became ill.

There after my said daughter talked to the Officer in charge of Adra Police Station and informed the entire facts and circumstances of that incident. Thereafter police come to the spot and unlocked all the four corner of the house. In this situation we are feeling insecure to stay in our house.

I further state that said Litton Bose, my daughter-in-law by relation, by putting me in fear of injury extorted my bank balance from my Allahabad Bank Pension Account no: 22383659565 and some other deposits and thereby said Litton Basu committed criminal breach of trust.

Thereafter the said Litton Basu again came outside my house on 10.08.20 and threatened us with dire consequences. We, the old aged senior citizens felt insecure in our house and if we or either of us killed, the said Litton Basu and her associates shall be responsible.

I must mention that due to her such activities her children expressed their unwillingness to stay with their mother before the Learned Court and Learned Court was pleased to pass an order to that effect. In this situation you are requested to take appropriate action as per law of the land against said Smt. Litton Basu for her such illegal and harmful activities.
