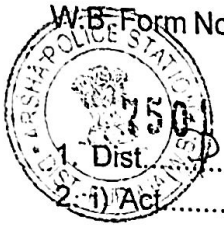

Sir,

I am producing herewith following arrested accused persons for the fact that, today (05.08.20) at about 08.15 hrs during my mobile duty (Arsha PS GDE No. 132 dtd 05.08.20) with (i) C/970 Dolon Biswas (ii) C/628 Giridhari Bauri of Arsha PS (iii) C/252 Anil Tamang (iv) C/292 Ajiul Rahaman of SAP 7th BN Camp at Arsha PS vide Arsha PS Spl. CC No. 1059/20 dtd 05.08.20 had been at Aharrah morh and found following arrested persons were wandering there without mask violating lockdown order and afterwards detained them at the spot. Being asked, they could not be able to give any satisfactory answer for wandering there without mask of such type protective gear and thus committed negligent act likely to spread infection of diseases dangerous to life and violated Quarantine rule. As such all the violated the Govt. Order during this Covid-19 pandemic situations. Furthermore, all those persons were making & circulating false alarm or warning as to disaster or its severity or magnitude, leading to panic among people as well as society. Accordingly, all they were arrested between 18:05 hrs to 18:55 hrs and brought to PS.
