
I am producing herewith following arrested accused persons for the fact that, today (08.08.20) at about 08.45 hrs during my mobile duty (Arsha PS GDE No. 228 dtd 08.08.20) with (i) C/970 Dolon Biswas (ii) C/894 Dhananjay Mandal (iii) L/C- 323 Baishaki Soren of Arsha PS (iv) C/252 Anil Tamang (v) C/292 Tajiul Rahaman of SAP 7<sup>th</sup> BN Camp at Arsha PS vide Arsha PS Spl. CC No. 106/20 dtd. 08.08.20 had been at Naya morh and found following arrested persons were wandering there without mask and afterwards detained them at the spot. Being asked, they could not be able to give any satisfactory answer for wandering there without mask of such type protective gear. As such all the violated the Govt. Order during this Covid-19 pandemic situations. Furthermore, all those persons were making & circulating false alarm or warning as to disaster or its severity or magnitude, leading to panic among people as well as society. Accordingly, all they were arrested between 16:45 hrs to 18:05 hrs and brought to PS.
