Sir,

I am producing herewith following arrested accused persons for the fact that, today (21.08.20) at about 12.15 hrs during my mobile duty (Arsha PS GDE No. 639 dtd 21.08.20) with (i) C/583 Khirod Baran Sardar (ii) C/628 Giridhari Bauri of Arsha PS vide Arsha PS Spl. CC No. 109/20 dtd. 21.08.20 had been at Karandih morh and found following arrested persons were wandering there without mask and afterwards detained them at the spot. Being asked, they could not be able to give any satisfactory answer for wandering there without mask of such type protective gear and thus committed negligent act likely to spread infection of diseases dangerous to life and violated Quarantine rule. As such all the violated the Govt. Order during this Covid-19 pandemic situations. Furthermore, all those persons were making & circulating false alarm or warning as to disaster or its severity or magnitude, leading to panic among people as well as society. Accordingly, all they were arrested between 16:05 hrs to 17:05 hrs and brought to PS.
