

IN THE MATTER of an application u/s 156(3) of the code of Criminal Procedure:-




MOST RESPECTFULLY SHEWETH:-

- 1. That the complainant is a permanent resident of the Purulia district under Purulia (M) Police Station.
- 2. That the elder sister of the complainant namely Fulu Kuiry got married to Ramakanta Kuiry s/o Sudhir Kuiry accused no 1 resident of village Sindri, P.S. Bagmundi, District Purulia almost about 20 years ago. It is pertinent to mention that out of the wed she gave birth to a male and a female child.
- 3. That on 28.02.2020 the undersigned received an information from his brother-in-law, Ramakanta Kuiry, accused no 1 that his wife Fulu Kuiry is missing and they could trace her. After this shocking information the undersigned visited the matrimonial house of his siter but could not gather any information. Later on he visited Bagmundi P.S. and informed the fact and accordingly the police personal assured to take action immediately. Till date there has been no development in finding Fulu Kuiry, sister of the complainant.
- 4. That the undersigned again visited Bagmundi P.S. after the lockdown was unlocked for COVID -19 and wanted to submit a written complaint against Ramakanta Kuiry that he strongly believes that his brother-in-law Ramakanta Kuiry have done some misdeed with his sister and vanished her in connivance with the accused no 2 but the police personals refused to accept his complaint for reasons unknown.
- 5. That the undersigned submitted the written complaint to the Bagmundi P.S. through registered post on 01.07.2020 but still no complaint was registered. The copy of the complaint and the postal receipt is annexed herewith.
- 6. That the complainant thereafter submitted a written appeal to the Superintendent of Police Purulia which was received in his office on 13.07.2020. Nonetheless nothing fruitful happened.
- 7. That the instant complaint should be sent to the officer in Charge of Bagmundi P.S. u/s 156(3) Cr.P.C. for treating it as a FIR and to start a specific case against the person. To unearth the unvarnished truth a detailed investigation and probe is very much necessary.



It is therefore prayed that your Honour will be pleased to send this compliant u/s 156(3) Cr.P.C. to O.C. Kenda P.S. with further directions for its investigation to be done in the interest of justice.

And for this act of kindness, your petitioner in duty bound shall ever pray.
