The above named complainant begs to state


as follows:-

1---- That your petitioner, the witnesses, and the accused persons are residents of the same village Sindri, P.S. Baghmundi, District Purulia. The accused persons are the neighbours of the petitioner and live side by side in the village.

2----That the accused persons suspected the complainant as an witch and due to that long ill terms prevails in between the family of the complainant on one side and the accused persons on the other. The accused persons off and on assaulted the complainant and threatened her that they would drove out her from the village.

3----That on the date of occurrence, the complainant went to fetch water from the well at that time, accused Malati Mahato, Srimati Mahato and Saraswati Mahato taking the name of the complainant throwing insulting and objectionable words against her i.e. indirectly pointing the complainant. The complainant immediately asked accused Saraswati Mahato and other accused persons as to whom the were meaning such words. At this, the accused persons told her that "you are witch, you are witch, we are referring you, we are pointing you, you tried to kill the children of Saraswati by your witch craft, you may do whatsoever you like against us. At this, there was hot altercation and quarrel between the parties. Then the accused persons left the place saying that wait we shall teach you a good lesson. The complainant did not take the threat seriously and came back to her house.

4----That on the same day at about 10.00A.M. all the accused persons armed with various weapons like Lathi, Jharu ( ) etc. all on a sudden criminally trespassed the house of the complainant , forming an unlawful assembly , started abusing the complainant, asked the complainant that "Sali Daini Beria aai, aaj tor rakter tika libo ajj tor shes din , Sarawatir Chhele Meyeder bhalo na korle tor barite aagun lagab , toke gram theke tarabo ". The complainant and her husband protest such defamatory words of the accused persons, at this accused Khagen Mahato and Ramnath Mahato entered in the house of the complainant and caught hold the hair of the complainant and dragged her out in the courtyard and started to assault by Lathi all over her body . Both the accused persons intentionally and forcibly torn the Saree and Blouse of the complainant, semi naked her and out raised her modesty in presence of the villagers in the broad day light . Accused Malati Mahato, Srimati Mahato and Saraswati Mahato assaulted the complainant indiscriminately with Jharu ( ). Hearing hue and cry the witnesses and the other villagers come to the spot and seeing them the accused persons hurriedly left the place saying that they would murder the complainant today or tomorrow. Due to fear and panic of the accused persons she did not dare go to Hospital for treatment.



5---That your complainant reported the matter to the Officer in Charge Baghmundi Police station as well as the Superintendant of Police Purulia but of no good though the accused persons committed the offence punishable U/S 147-149-448-323,324,500,506/34 I.P.C.

6----That your complainant is a very poor woman . She is helpless having no source of in come whatsoever . She is not in a position to conduct the case on her own expense . Moreover , there are some technical and legal aspects involved in this case which also requires considerable money and machinery . For all these , it is highly desirable that this case should be converted to a police case for thorough Police investigation.

It is prayed that your Honour may be graciously

Pleased to direct the Officer In Charge Baghmundi Police Station to investigate the case in accordance with law , treating the same as F.I.R. , as contemplated U/S 156(3) Cr.P.C.
