In producing herewith the 05 (five) arrested accused persons namely (1) Subal Sekhar (19 yrs) S/O-Pankaj Kr. Sekhar (2) Sukdev Karmakar (20 yrs) S/O-Haripada Karmakar both of Vill-Chowra, PS-Patamda, Dist-East Singbhum, Jharkhand (3) Dipankar Das (41 yrs) S/O-Murali Mahan Das Vill+PS-Bandwan, Dist-Purulia (4) Ranjit Kr. Mahato S/O- Lt. Hrisikesh Mahato (30 yrs) of Vill-Pairaguri PS-Galudih, Dist-East Singbhum, Jharkhand (5) Mahabir Paul (54 yrs) S/O-Lt. Kedarnath Paul of Vill-Tentulia PS-Chakulia, Dist-East Singbhum, Jharkhand along with following 03 (three) seized Motor Cycles i.e. (1) One red black colour Hero Passion plus Motor Cycle having No. JH-05B/0271 vide Engine No. 01K21M03853 & Chassis No. 01K21C03861 (2) One Black colour Hero Splendor plus Motor Cycle (new) having Engine No. HA10AGK4D01543 & Chassis No. MBLHAW080K4D00709 without Number Plat (3) One red-black colour Honda shine SP Motor Cycle having No. WB-56M/3142 vide Engine No. JC73ET1141467 & Chassis No. ME4JC734GHT07811, I SI Banshi Dhar Mukherjee of Bandwan PS, beg to report that as per your kind order vide Bandwan PS GDE No-289 Date-08.08.20 & C.C No-2367/20 Date-08.08.2020 on today i.e. on 08.08.2020 at about 12:45 hrs while myself along with force were performing Day mobile duty at Bandwan Bazar area and found the above noted 05 (five) persons were roaming aimlessly without any face cover mask with motor cycle at Bandwan Bazar area. In course of my duty with the help of accompanied force I intercepted them at Bandwan Chwak Bazar. On being asked they could not able to give any satisfactory answer for their movement on road and public place at that time, where unnecessary public movement restriction is going on due to lockdown. Lockdown is going on throughout the District of Purulia in view of Pandemic of COVID-19 outbreak. In this respect order of Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020, 10/04/2020 & 01/05/2020 and order of Govt. of West Bengal vide Order No-177-CS/2020 dt-18.05.2020, 218-CS/2020 dt-30.05.2020, 272-CS/2020 dt. 30.06.2020 & 283-CS/2020 dt.-21/07/2020 are in force. As such the above noted persons violated the order during this pandemic situation. Moreover the detained persons were refuses to comply the direction given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic. Accordingly, the above noted persons were arrested after maintaining all formalities regarding arrest and prepared arrest memos and seized the above noted 03 (three) Motor Cycles & brought them to P.S with seized Motor Cycles. Therefore, I am praying legal action U/S-188/34 IPC & read with section 51 of Disaster Management Act, 2005. may kindly be started against above mentioned accd. persons & oblige.
