As such the above noted persons violated the order during this pandemic situation. Moreover the detained persons were refused to comply the directions which are given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic Accordingly, the above noted persons were arrested after maintaining all formatties regarding arrest and prepared arrest memos and seized the above noted Motor Cycle 8 brought them to P.S with seized Motor Cycle.

Hence it is prayed before you that above mentioned persons may kindly be prosecuted U/S 188/34 IPC & Read with section 51 of Disaster Management Act, 2005.
