

In producing herewith four (04) arrested accused persons (1) Sunil Ch. Hembram (47 yrs) S/O-Lt. Dharam Hembram of Vill-Sagasupururi, PS-Bandwan, Dist-Purulia, (2) Rakesh Mahato (20 yrs) S/O-Tarani Mahato (3) Ajoy Orang (19 yrs.) S/O-Pashupati Orang Both of Vill-Banabir, (4) Brihaspati Mahato (21 yrs) S/O- Durjadhan Mahato of Vill-Murgabera. Sl No-2-4 of PS-Barabazer, Dist-Purulia along with one seized Motor Cycle i,e One blue colour Honda SP Shine Motor Cycle having bearing Reg. No-JH-05BY/9278,Chassis No. MB4JC734LHT140846 & Engine No. JC73ET1253861. J SI BIswajit Sarkar of Bandwan PS. beg to report that as per your kind order vide Bandwan PS GDE No-1053 Date-27.08.20 & CC No-2552/20 Date-27.08.2020 today i.e on 27/08/2020 at about 16.15 hrs while myself along with force were performing mobile duty while we reached at Chawk Bazar under Bandwan PS and found the above noted persons (Sl No-2-4 together) in a Motor Cycle and another one (Sl. No-1) were coming from Barabazer side without any face cover mask. Police party detained them at Bandwan chawk Bazar under Bandwan PS. On being asked they could not able to give any satisfactory answer for their movement on road and public place at that time, where unnecessary public movement restriction is going on due to lockdown. On enquire it also revealed that three persons (SL No-2-4) is the inhabitant of Barabazer PS without any valid reason he was moving at Bandwan Jurisdiction. Lockdown is going on throughout the District of Purulia W.B in view of Pandemic of COVID-19 outbreak. In this respect order of Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020. 10/04/2020 & 01/05/2020. And order of Govt. of West Bengal vide Order No- 177-CS/2020 dt-18.05.2020 & 218-CS/2020 dt-30.05.2020, 272-CS/2020 dated 30.06.2020 are in force. As such the above noted persons violated the order during this pandemic situation. Moreover the detained persons were refused to comply the directions which are given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic. Accordingly, the above noted persons were arrested after maintaining all formalities regarding arrest and prepared arrest memos and seized the above noted Motor Cycle & brought them to P.S with seized Motor Cycle.

Hence it is prayed before you that above mentioned persons may kindly be prosecuted U/S 188/34 IPC & Read with section 51 of Disaster Management Act, 2005.
