Sir,

In producing here with accused **Kailash Pati Mahato S/O-Sudhir Ch. Mahato** and seized alamot

- One bike bearing reg no JH 05 AG 1867, model Yamaha YBR, red and black,
- Two numbers of Hari (হাড়ি) loaded with approx 3 kgs of rice, 1 Kg Dal,
- One Aluminum Balti, (বালতি)
- One plastic Mug, (মগ)
- some of SHAL PATA er Thala, (শাল পাতা এর থালা)
- SIX no of water bottle of 1 liter each
- One stove of Kerosin oil,
- Two full bottles of country spirit 60 UP,
- 08 empty bottles of country spirit 60 UP,
- One lock and key of main gate of school in unlocked condition,

to the effect that during evening patrol duty I along with my accompanied force namely C/-1147 Bappaditya Nandi & C/1130 Asik Ansari, vide Barabazar PS GDE No-949 & C.C No-2786 Dtd. 16/08/2020 received a source information via duty officer ASI Deb Kumar Chattaraj, at about 21.15 hrs vide GD entry no 962 dt 16/8/2020 (as informed) that a mass gathering took place at Latpoda Jr Basic School. As per direction of I.C Barabazar PS myself along with force rushed to the spot, on way informed concern V.P Uttam Mahato and CVF Alok Mahato to reach the spot.

Accordingly he also reached the spot along with us at 22.05 hrs and on seeing the Police team the mob fled away from the spot and found that a mass gathering was gather there violating the norms of COVID-19.

They opened the educational institute under leadership of teacher of the school Islam Ansary S/O-Himmat Ansary without the permission of SI of School or others. In this time of pandemic days all the schools are closed as per order. As teacher he broke the laws of government. This may spread infection. Their malignant act is likely to spread infection of disease which is dangerous to life.

Held an enquiry and learnt that from the reliable sources that the above noted persons and others were gather there over the meeting and picnic. They violated the lock down rules though lockdown is going on throughout the District of Purulia in view of Pandemic of COIVD-19 outbreak vide Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020 and 10/04/2020 for complete restriction measure. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. vide Order No-40-3/2020-DM=1(A), GOI, MHA, 30th May 2020. In this time any non essential movement in between 21.00 hr to next morning 05.00 hrs are strictly restricted. The above noted persons broke the norms intentionally to cause more hindrances in the society.

One Kailash Pati Mahato S/O-Sudhir Ch. Mahato cannot give satisfactory answer about such type of activities like none wearing of mask and gathering also failed to give satisfactory answer for such type of movement in Indiscipline manner. He and absconding others violated the order duly promulgated by government through public servants and through media etc for prevention of attack from CORONA Virus/COVID-19. They were creating annoyance to the society & violated govt order vides Order No- 272-CD/2020 Dtd. 30.06.2020 duly promulgated vide Memo No- 382-I.S.S/2M-24/2020 Dtd. 02.07.2020.

Accordingly, I arrested Kailash Pati Mahato S/O-Sudhir Ch. Mahato for Disobedience to order duly promulgated by public servant; after maintaining all rules of arrest, Issued memo of arrest. I informed him & his relatives regarding the ground of arrest i.e. as per section 3 of the Epidemic Diseases Act, 1897, for disobeying any regulation or order made under the Act. These are according to Section 188 of the Indian Penal Code (Disobedience to order duly promulgated by public servant). At prima facie there were sufficient evidences to secure their detention.

From the local primary enquiry as well as data collected from detained person it came to light that the meeting was also attended by

The process of seizure took place in between 22.15 and 22.45 and arrest was done in between at 22.50 hrs. There was every chance of breach of peace and requiring of offence if not arrested. As there was lock down in the area the peoples left the place and did not agreed to come forward to remain present as witness. I also refrained myself from encouraging much people to come out from home to remain present in the Police work in this time of Lock Down.

After completion, on arrival at PS I type this letter of complaint at our PS computer and submitted to I.C Barabazar through duty officer ASI Deb Kumar Chattaraj for taking necessary action against
