In producing herewith the Three (03) arrested accused persons namely 1) Bapi Sengupta (25 yrs) S/O- Ashoke Sengupta 2) Sanjoy Majhi (29 yrs) S/O- Rampada Majhi 3) Manik Majhi (40) S/O- Lt. I, SI Joydeb Mahato of Hura PS beg to report that the series of 2020 myself along with force

I, SI Joydeb Mahato of Hura PS beg to report that on the evening of 08.08.2020 myself along with force viz, C/580 Pradip Kr Bag, JC/1347 Sushil Mahato and NVF 908 Lakhindar Sing Mura were performing Night patrolling duty at Hura Kandbona More area vide Hura PS GDE No- 274 and CC No- 2281/20 dated 08.08.2020 with Govt. vehicle WB 56C/0016. At 22:25 hrs Hrs received a credible source information that 10/12 persons being armed with deadly weapons assembled in an open place near Lalpur telecom maidan under Hura PS with a view to commit dacoity on vehicular traffic which were playing on NH60A (Bankura – Purulia) road. The information was communicated to O/C Hura P.S and as per his direction myself along with another officer ASI Biswajit Kalindi along with his accompanied force namely C/633 Dasharath Sing Mura, JC/1374 Belal Ansary assembled at Hura Nimtala More and left for the possible place of occurrence. We reached at the spot just ½ km before the place of occurrence at 22:45 hrs. Keeping the vehicle in a safe distance, we started on foot and slowly arrived near the spot and heard some whispering of some persons. We the Police party without wasting a single moment tried to encircle them from behind. With the help of the focus of the torch light we found that 10/12 persons being armed with deadly weapons like rod, shabal, lathi were assembled in an open place beside the Lalpur telecom maidan. Seeing the Police party all of them started to escape but after a hot chase the above 03 accd. persons could be apprehended.

On primary interrogation the apprehended accused persons stated their names and addresses as noted above and they also informed that one Sagar Bouri S/O- Lt. Mantu Bouri of Vill- Gundlubari, PS- Hura, Dist.- Purulia and 10/12 others were assembled there for committing dacoity over vehicular traffic playing on NH6OA (Bankura — Purulia) road was quite dark and tranquil. Before entering into the search of the person of the accd persons, tried to find out some local independent witnesses but as the place is an isolated one none could be available.

During search of the said accd persons 1) One iron rod length 5 feet approx was recovered from the possession of accused Bapi Sengupta (25 yrs) S/O- Ashoke Sengupta in his right hand, 2) One bamboo stick length 5 feet approx and one plastic Torch light was recovered from the possession of accused Sanjoy Majhi (29 yrs) S/O- Rampada Majhi in his right hand, 3) One iron made "BHOJALI" measuring 10 inch approx was recovered from the possession of accused Manik Majhi (40) S/O- Lt. Kalipada Majhi all of village- Daldali, PS- Hura, Dist- Purulia. So there is sufficient reasonable ground to believe that they were assembled there at that odd hours with deadly weapons with a view to commit dacoity on vehicular traffic. So, I arrested them, informing them of the ground of their arrest and seized the above articles under proper seizure list duly signed by witnesses and accd persons observing all formalities and procedures of law. The seizure was made between 23.15 hrs and 23.45 hrs on 08.08.2020.

Therefore I pray that a specific case may kindly be started against the above noted accd. persons and arrange for its investigation.
